## SUPPLEMENTARY RESULT NOTICE NO. 764 DATED 23.03.2021

### TGT (NATURAL SCIENCE) MALE, POST CODE-135/17 IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No.04/2017 dated 20/12/2017 had advertised total **222 vacancies (UR-143, OBC-33, SC-31 & ST-15 including PH/OH-03 & PH/VH-03)** for the post of **TGT (Natural Science) Male under Post code-135/17** in Directorate of Education with closing date as **31.01.2018**. Tier-I examination in online computer based examination mode was conducted on **29.09.2018**.

2. On the basis of online examination of Tier-1 held on **29.09.2018** and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of TGT(Natural Science), Post Code-135/17 in Directorate of Education, a total of **203 (UR-136, OBC-22, SC-29, ST-14, PH/OH-02)** were provisionally nominated vide **Result Notice No.455 dated 28/05/2019** and **13 candidates were kept pending for want of deficient documents in the e-dossier**. Further, **09 candidates (UR-01, OBC-06, SC-01 & ST-01)** were nominated from pending candidates and **04 candidates were kept pending for want of deficient documents in the e-dossier vide Supplementary result Notice No.533 dated 09.10.19**. Later, the user department vide letter dated 27/12/2019 had returned 09 dossiers reasoning thereby 09 vacancies were created in their respective category. Therefore, **12 candidates (UR-09, SC-01, ST-01 and PH/OH-01)** were provisionally nominated vide **Supplementary Result notice No. 599 dated 13/02/2020** and **01 candidate** under SC category was provisionally nominated vide **Supplementary Result Notice No. 697 dated 20.10.2020**. 01 vacancy under UR category has been kept pending for court case candidate in W.P. (C) No. 12044/2019.

3. Further, the User Department has returned 13 dossiers after expiry of waiting panel for which no substitute candidate could be provided against these returned dossiers. However, the Competent Authority has extended the validity of waiting panel upto 31.12.2020 and hence, the qualified/suitable candidates from waiting panel have been taken into consideration for nomination in their respective categories as per their merit.

4. Accordingly, in continuation to Result Notice No.455 dated **28.05.2019**, supplementary Result Notice No.533 dated **09.10.2019**, Supplementary Result notice No. **599 dated 13/02/2020 & Supplementary Result Notice No. 697 dated 20.10.2020**, the candidates detailed below are also provisionally nominated on the basis of online examination of Tier-I held on 29.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification etc. in accordance with advertisement No.04/2017 and RRs for the post of **TGT(Natural Science) Male, Post Code-135/17**.

5. The selection of the above 14 candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the

information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

6. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2008, O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.

9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.

10. The user department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.

11. The result process for the above post code stands closed in all respect except 01 vacancy under UR category due to pending for court case candidate.

12. Further, as per result notice no. 455 dated 28/05/2019 wait list panel for the post code 135/17 was valid for a period of one year, i.e. upto 27.05.2020. However, the same has been extended upto 31.12.2020.

13. The category-wise marks obtained by the last provisionally nominated candidate are as under:-
