JUNIOR CLERK (POST CODE 19/15)
IN DELHI TRANSPORT CORPORATION

1. The DSSSB vide its Advertisement No. 01/15 with closing date 26/11/2015 had advertised 57 vacancies (UR-30, OBC-15, SC-08, ST-04 including HH-01, VH-01) for the post of Junior Clerk in Delhi Transport Corporation under Post Code 19/15. Board Conducted Tier-I written examination for recruitment in respect of this post on 10/10/2019 and 11/10/2019.
2. On qualifying Written Examination, vide Notice No. 889 dated 23/01/2020, the DSSSB has shortlisted 585 candidates for appearing in Skill Test/Typing Test for the post of Junior Clerk under Post Code 19/15. The Skill Test was conducted on 16/02/2020 for VH candidates and from 22/02/2021 to 25/02/2021 wherein out of 585 candidates, 385 candidates appeared for the test. In the Skill Test conducted, out of 385 candidates only 346 candidates could qualify.
3. As per RRs for the Post the candidate was to qualify the 30 w.p.m. in typewriting in English or 25 w.p.m. in typewriting in Hindi.
4. The roll numbers of the 346 candidates who have qualified the skill test are as under:-

Based on the performance in the written examination and being qualified in Skill Test, 130 candidates (UR-62, OBC-33, SC-16, ST-12, HH-02 and VH-05) out of 346 candidates who have qualified the typewriting skill test in their respective category as per details given below are being provisionally shortlisted and accordingly allowed to up-load e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form.

Note:-

* The candidate bearing roll no. 5160000264 having date of birth 16/02/1992, being older in age than other candidates having equal marks in Written Examination, has been the last shortlisted candidate for uploading e-dossier in OBC Category.

** The candidate bearing roll no. 5160000411 having date of birth 31/08/1987, being older in age than other candidates having equal marks in Written Examination, has been the last shortlisted candidate for uploading e-dossier in SC Category.

6. The shortlisted candidates for the above-mentioned post/post code are hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/Professional/Experience Certificates/Degree and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module.

Short listing is being made on the basis of marks obtained in Tier-I examination (Objective-MCQ) for 200 marks and being also qualified in skill test.

7. Kindly note that the e-dossier link will be activated to only those candidates who are provisionally shortlisted to upload e-dossier as per details given in para 5 above.
8. All the candidates who have been shortlisted for falling in consideration zone of selection **MUST** upload their all requisite/applicable documents in the said link in stipulated time.
9. The e-dossier link shall be active from 31/03/2021 to 14/04/2021. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of Closing date of application, i.e., 26/11/2015.
10. The above shortlisted candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID as an additional facility. If any candidate fails to upload the e-dossier during their above said period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
11. All the candidates who have shortlisted for uploading e-dossiers **MUST** upload their all requisite/applicable documents in the said link in stipulated time i.e., 31/03/2021 to 14/04/2021
12. **Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his candidature will be treated as cancelled.**
13. The above shortlisting of candidates for calling of e-dossier for the post code -19/15 will be subject to outcome of pending court cases, if any.
14. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
