- 3. The shortlisted candidates will have to mandatorily qualify the Skill Test, failing which he/she shall not be eligible for the post of LDC, JSA and Record Keeper/Record Clerk. However, no Skill Test is required for the post of Stockman and allocation shall be done on the basis of merit-cum-preference.
- 4. The shortlisted candidates will also have to mandatorily upload their documents and mark their preference for the post and department by logging into the website www.apssb.nic.in using their credentials from 25/03/2021(12:00 pm) till 27/03/2021 (03:00 pm).
- 5. Result in respect of two posts of PwD is withheld to ascertain the category of PwD candidates in order to shortlist them against the PwD vacancy. A link shall be shared shortly wherein they will have to specify their sub-category under PwD category and upload the necessary document in its support. In case such candidates have already been shortlisted in para 2 above against unreserved /APST category, then they may seek prior exemption from skill test by producing certificate from Authorized Medical Board / Civil Surgeon (where there is no such Board), as prescribed. The certificate shall be uploaded online during document upload process as mentioned in para 4 above.

6. The allocation of post and department shall be done after document verification and skill test, based on eligibility and merit-cum-preference. Provisionally selected candidates after skill test shall be allotted departments only as per the preferences indicated. Failure to upload documents and/or mark preferences shall result in rejection of candidates and non allotment to any posts. Allocation of departments for PwD candidates will be against the vacancies of Department of UD & Housing and Office of the PCCF.

7. The candidature of all the shortlisted candidates is PROVISIONAL, subject to eligibility in all respects as prescribed in the Advertisement and Recruitment Rules. The candidates would be required to produce the original certificates in support of their claim relating to age, educational qualifications, category etc.

8. The details regarding Skill Test and Document Verification shall be intimated shortly. The qualified candidates are advised to check the website www.apssb.nic.in regularly, for any/all updates/notices.

9. Candidates must note that their Candidature is purely provisional at this stage and their appointment will be subject to their name figuring in the provisional Merit list which shall be prepared after the Skill Test. Apart from that, they should fulfill the eligibility criteria as per Advertisement No. 03/2019 dated 09.01.2019 addendum dated 31.07.19, 20.12.2019 and Corrigendum dated 08.08.2019 including possession of the requisite document, failing which their Candidature may be summarily rejected at any stage.

10. Further the Appointing Authority i.e., the indenting/user department verifies and satisfies itself about the authenticity of documents/certificates and eligibility as per the Recruitment Rules before finally appointing the candidate(s) and character and antecedents of the candidates. Therefore, the provisional shortlisting/selection of a candidate does not confer upon him/her any right of appointment unless the Appointing Authority is satisfied, after such inquiry as may be considered necessary, that the candidate is suitable in all respects for appointment to the post.
