ID 66315240) now falls at Serial No. 30 as per his merit in the amended Final *merit wise list of candidates who have been selected against posts reserved for "SC/ST OF HARYANA"* displayed vide Notice No. 157/S.S.S.C. dated 24.03.2021. Accordingly, the candidates shown at **Serial No. 30 and onwards**, be treated as Serial No. 31 and onwards upto Serial No. 49 in the said List.

Sh. Ankur (Reg. ID 66207814) now falls at Serial No. 45 in the amended Final *merit wise list of candidates who have been selected against posts reserved for "SC/ST OF HARYANA"* and is shifted to Sirsa Sessions Division instead of Gurugram Sessions Division, as per his merit.

Accordingly, Candidate namely **Sh. Parvinder Bhardwaj (Reg. ID 66270639)** shown at Serial No. 192 of *Merit Wise List Of Candidates Who Have Been Selected Against Unreserved/ General Vacancies* and had been selected against unfilled reserved post in the list of General/Unreserved Category is shifted to Mewat Sessions Division instead of Sirsa Sessions Division, as per his merit.

Consequently, **Ms. Monika (Reg.
