PHARMACIST, POST CODE-02/18 IN HEALTH & FAMILY WELFARE DEPARTMENT

The Board had declared Result for the post of Pharmacist, post Code-02/18 in Health & Family Welfare vide Result Notice No. 632 dated 15.06.2020 wherein 85 candidates were provisionally nominated and candidature of 20 candidates who were in merit was rejected for not uploading of their documents in the e-dossier w.e.f. 24.03.2020 to 07.04.2020.

2. However, a spate of representations have been received from such candidates seeking extension of time for uploading the documents and few of them have approached the Hon'ble CAT as well, which in turn has disposed off such applications with directions to the Board to dispose of the applications by passing appropriate speaking orders.

3. The stipulated period of uploading of the e-dossier got scheduled during the period of lockdown w.e.f. 24.03.2020 to 18.05.2020 (date of first unlock) imposed due to COVID-19 pandemic by Govt. of India.

4. Therefore, after due deliberations, it has been decided that in view of the extra-ordinary circumstances arising out of the COVID-19 pandemic, wherein the entire country had to be placed in a lockdown w.e.f. 24.03.2020(Midnight) to 18.05.2020 and all physical movement of citizens were curtailed and all markets/services closed by Govt. of India and it was declared illegal to make any kind of movement, the candidates too were legally bound not to make any physical access to the computers/internet etc., they were physically restrained to seek any access to internet service providers such as Cyber Cafes or such I.T enabled services. Keeping in view of this fact of lockdown, the candidates who failed to upload their e-dossier during lockdown period, were allowed another opportunity because of the above referred extraordinary circumstances w.e.f. 06/10/2020 to 15/10/2020 by withdrawing the **Rejection Notice No. 634 dated 15.06.2020** and the candidature of the candidates who failed to upload their e-dossier during 24.03.2020 to 07.04.2020 was revived for the post of Pharmacist, Post Code-02/18 in Health & Family Welfare Department.

5. Some candidates have uploaded their documents in the e-dossier due to which the merit under UR Category (Sub-Category-PH/OH) become higher. The marks of last nominated candidate under PH/OH category are 73.22 marks.

6. Therefore, in partial modification of **Result Notice No. 632 dated 15.06.2020** for the post of Pharmacist, Post Code-02/18 in Health & Family Welfare, the candidature of the candidate having **Roll No. 11140200480 under UR/PH/OH category** is hereby withdrawn for being lower in merit and kept in waiting panel.

7. The rest of the contents of the result notice No. 632 dated 15.06.2020 shall remain same.
