NOTICE

Subject:- Declaration of Marks of Physical Endurance Test held during period of 11/01/2020 to 22/02/2020 for the post of Fire Operator in Delhi Fire Service, Post code -18/19.

The DSSSB advertised **706 vacancies (EWS-21, UR-190, OBC-115, SC-309 and ST-71)** for the post of fire Operator, Post code 18/19 in Delhi Fire service vide advertisement No. 04/19 dated 24.09.2019.

The DSSSB conducted Physical Endurance Test (PET) during the period of 11/01/2020 to 22/02/2020 for the post of Fire Operator in Delhi Fire Service, Post Code- 18/19.

Total 33,997 candidates appeared in said PET. As per mode of selection/examination scheme (Annexure -1 of advertisement No. 4/19 dated 24/09/2019, **The Physical endurance Test (PET) consists of 100 marks and performance score was from 1 to 10 points-each point equivalent to 3.333. Further, a candidate will have to qualify in each of the three events i.e, Long Jump, High Jump and 800 Mtr Run and have to obtain minimum 33% marks in aggregate to be declared 'PASS' in PET.**

In view of the above, points scored by all the candidates in PET have been multiplied by a factor of 3.333 for the purpose of calculating their marks in PET. **All the candidates who have qualified each of the above said event and scored a total of 10 or above points (33.33 Marks) in aggregate have been declared as 'PASS' in PET and shortlisted for Written Examination.**

The marks obtained by 33,997 candidates duly appeared in physical endurance test conducted during 11/01/2020 to 22/02/2020 have already been uploaded on the Board's Website. Candidates can view their marks by logging into their account in OARS module at www.dsssonline.nic.in.

Accordingly, a Total of 25,505 candidates have been shortlisted for appearing in written examination to be conducted by the board. The admit card for the shortlisted candidates will be issued by the DSSSB shortly.
