PRESS NOTE

Himachal Pradesh Staff Selection Commission today declared the final result for the recruitment of **19** posts {**Gen (WXSM)-11, OBC (WXSM)-03 SC (WXSM)-04 & ST (WXSM) - 01**} of **Pharmacist (Allopathy)** (on contract basis) **Post Code: 777**, in response to requisitions received from the **Director Health Services, Himachal Shimla-9** and advertised vide advertisement No. **36-1/2020** dated **02.03.2020**.

In response to this advertisement, **2138** applications were received out of which **242** applications were provisionally admitted for written objective type screening test.

The Written Objective Type Screening Test was held on **12.12.2020** in which **138** candidates appeared and **104** candidates remained absent.

Based on the merit of Written Objective Screening Test held on **12.12.2020**, **18** candidates were called for evaluation process on government notified parameters which was conducted on **10.03.2021**. The Commission has compiled the final result of **19** posts of **Pharmacist (Allopathy)** (on contract basis) **Post Code: 777**.
