LEGAL ASSISTANT (POST CODE 11/19) IN DELHI POLLUTION CONTROL COMMITTEE

- 1. The DSSSB vide its Advertisement No. 02/2019 with closing date 05/03/2019 had advertised 05 vacancies (UR-04, OBC-01) for the post of Legal Assistant in Delhi Pollution Control Committee (DPCC) under Post Code 11/19. Board Conducted Tier-I written examination for recruitment in respect of this post on, 25/08/2019. The Board had conducted Tier-I (T) written examination on 25/08/2019 (online). Board had declared marks of Tier I written examination of the Candidates of the Post of Legal Assistant in Delhi Pollution Control Committee under Post 11/19 vide notice number 855 dated 16/12/2019.
- 2. Based on the Tier I written examination declared vide notice no. 855 dated 16/12/2019 following 05 candidates having following roll numbers are now provisionally allowed to upload their e-dossiers subject to correctness of the information furnished by the candidates in their online application form to fill up vacancies created due to returned dossiers of 01 UR candidate by user department i.e. Delhi Pollution Control Committee:-

*The candidate having roll no. 11200300054 having DOB 01/03/1990 being older in age in UR category is the last shortlisted candidate in UR category to whom e-dossier has been called.

*The revised cut off marks for calling e-dossier is 99.25 in UR Category.

- 3. The documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out.
- 4. The shortlisted candidates for the above-mentioned post/post code are hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/Professional/Experience Certificates/Degree and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module. Short listing is being made on the basis of marks obtained in Tier-I examination (Objective-MCQ) for 200 marks.

- 5. Kindly note that the e-dossier link will be activated to only those 05 additional candidates who are provisionally shortlisted to upload e-dossier as per details given in para 2 above.
- All the candidates who have been shortlisted for falling in consideration zone of selection MUST upload their all requisite/applicable documents in the said link in stipulated time.
- 7. The e-dossier link shall be active from 25/05/2021 to 08/06/2021. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of closing date of application, i.e., 05/03/2019.
- 8. The above shortlisted candidates are also being separately informed through SMS and email on their registered mobile number and e-mail ID as an additional facility. If any candidate fails to upload the e-dossier during their above said period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 9. All the candidates who have shortlisted for uploading e-dossiers MUST upload their all requisite/applicable documents in the said link in stipulated time i.e., 25/05/2021 to 08/06/2021.
- 10. Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his candidature will be treated as cancelled.
- 11. The above short listing of candidates for calling of e-dossier for the post code -11/19 will be subject to outcome of pending court cases, if any.
- 12. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
