- 3. The concerned candidates are required to download "Attestation Form" and "Bio- Data form" from the website of the Commission and bring duly filled-in.
- 4. The participation in the document verification doesn't reserve any right for appointment in the service in the event the candidates fail to fulfill the eligibility criteria as per terms & conditions of the above advertisement.

Special instructions & guidelines for candidates in view of Covid-19

- a). Covid-19 test report (RT-PCR) showing "negative" (-ve) obtained from authorized laboratories of ICMR within 48 hours of the date of document verification to be brought by all candidates. No candidate shall be permitted for document verification, if Negative RT-PCR report not furnished.
- b). Self declaration by the candidates that he/she has not physically interacted with any Covid patient in last 07 days.
- c). The candidates should bring their own water bottles.
- d). Each candidate should carry his/her own sanitizer bottle and wear mask properly. No candidates shall be permitted to the document verification without proper masking.
- e. Each candidate should maintain social distancing norm of 6 feet while coming to the verification process.
- f). No candidate would be accompanied by any guardian or parent. Entry to the premises will be for candidates only.
