It is for information of all concerned that, the physical verification of original certificates, documents etc. & Viva Voce test in respect of **64 (21-w)** candidates, who have qualified & shortlisted in the written examination for recruitment to the post of **Assistant Executive Engineer (Electrical)** under Department of Energy, pursuant to the Advertisement No. **10 of 2019-20**, will be held in the office of the Commission at 19, Dr. P. The candidates are required to come with hard-copies of online application forms (indicating their Roll Nos. at the top right corner), three passport size photographs, self-attested copies of all relevant certificates, documents, Aadhaar Card etc. **with original of the same** as per **Para - 10** of the aforesaid Advertisement and duly filled in **“Attestation Form” & “Bio-data Form”** (to be downloaded from the website of the Commission) and submit the same **in person** on the day of verification.

It is also made clear that the candidature of these candidates for the recruitment is **purely provisional**. The candidature is liable to rejection in the event of inadequacy /deficiency found at any stage before or after the verification of original certificate /documents and is subject to fulfillment of terms and conditions laid down in the advertisement.

**Mere participation in the document verification does not reserve any right to appear the viva voce test.** The candidates shall be allowed to the viva voce test on the scheduled date & time mentioned below subject to fulfillment of their eligibility in all respect as per verification of original certificate /documents. The decision of the Commission thereon shall be final.

**Special instructions & guidelines for candidates in view of Covid-19**

- Covid-19 test report (**RT-PCR**) showing “**negative**” (-ve) obtained from authorized laboratories of ICMR within 48 hours of the date of document verification to be brought by all candidates. No candidate shall be permitted for document verification & viva voce test, **if Negative RT-PCR report not furnished.**
- Self declaration by the candidates that he/she has not physically interacted with any Covid patient in last 07 days.
- The candidates should bring their own water bottles.
- Each candidate should carry his/her own sanitizer bottle and wear mask properly. No candidates shall be permitted to the document verification without proper masking.
- Each candidate should maintain social distancing norm of 6 feet while coming to the verification process & viva voce test.
- No candidate would be accompanied by any guardian or parent. Entry to the premises will be for candidates only.
