Subject:- Declaration of Marks of Online written examination held on 20.04.2021 & 22.04.2021 for the Post of Fire Operator, Post Code-18/19 in Delhi Fire Service- regarding.

The DSSSB vide its advertisement No. 04/19 dated 24.09.2019 had advertised total 706 [EWS-21, UR-190, OBC-115, SC-309, ST-71 vacancies for the post of **Fire Operator in Delhi Fire Service, Post Code-18/19** with closing date as 06/11/2019. Physical Endurance Test (PET) was held w.e.f. 11.01.2020 to 22.02.2020. On the basis of qualifying marks in PET, the candidates were shortlisted for appearing in the online written examination which was held on 20.04.2021 & 22.04.2021.

2. **Online written examination was held on 20.04.2021 & 22.04.2021.**

3. The marks obtained by **18015 candidates** who duly appeared in examination conducted in **online mode on 20.04.2021 & 22.04.2021** have been uploaded on the Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssonline.nic.in.

4. As per the Board notice dated 26.04.2013, the minimum qualifying marks in one Tier written examination for different categories are as under:-

UR/General	:	40%;
OBC	:	35%;
SC/ST/PH	:	30%.

Ex-servicemen: will be given 5% relaxation in their respective categories subject to a minimum of 30%

5. On the basis of online written examination held on **20.04.2021 & 22.04.2021**, a total of **3367 candidates have qualified the written test and will be called for appearing the skill driving test. The candidates will be informed separately through notice on the website of the Board.**

6. Further, the result of written examination in r/o 04 candidates having roll No. **112400501140, 111900500309, 112800501334, 111200501115** have been withheld for further scrutiny of their candidature.

7. Mere asking the candidate for appearing in the Skill Test (Driving) does not confer him any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the

candidate fails to appear in the Skill Test (Driving), he will not be given any further opportunity and his candidature will be treated as cancelled.

8. While every care has been taken in preparing the list of qualified candidates, DSSSB reserve the right to rectify errors and omissions, if any detected at any stage or arising due to court case.
