The lodging & boarding during the induction training period will be provided by NSC for the outside candidates other than Delhi & NCR from 26.08.2021 (evening) to 27.08.2021 (evening).

The expenses on the **medical examination (max. ₹1000/- approx)** will be paid by the candidate himself/herself and the actual expense will only be reimbursed to him/her after joining the post at the designated place of posting.

It is also informed that above candidates are required to report at schedule date, time and place for medical examination. **No extension or second chance will be provided.** Failure to report for the same, it will be presumed that he/she is forgoing the opportunity and his/her candidature will be treated as cancelled. No further correspondence will be entertained in this regard.

Out of above mentioned candidates, those who have given any undertaking during document verification for submitting any document, will only be allowed to undergo medical examination after submitting the said document(s).
