IMPORTANT ANNOUNCEMENT

Public Service Commission, West Bengal will conduct the West Bengal Judicial Service (Preliminary) Examination, 2021 on Sunday, the 12th September, 2021. The e-Admit Cards for the examination will be uploaded at the Commission's website <https://wbpsc.gov.in> by 24.08.2021 for the convenience of the admitted candidates. The candidates are advised to download their e-Admit Cards for the examination and take a printout thereof on and from 24.08.2021, Tuesday. The admitted candidates shall have to produce the printout of their e-Admit Cards at the allotted venue for appearing at the specified examination. Candidates are directed to carry identical **two stamp size photographs** along with proof of identity in original such as Madhyamik or equivalent examination pass certificate/admit card which bears photograph of its rightful owner or Passport or pan Card or UID No. Card (AADHAAR) or EPIC (Voter Identity Card) or Driving Licence and the printout of e-Admit Card at the venue of the Examination. No paper Admit Card will be issued for this examination by the Commission and no such card will be sent to the candidates by post or will be available from the Commission's office.

The candidates are also advised to take a printout of the e-Admit Card well in advance to avoid last minute rush.

In case of any discrepancy in the e-Admit Card the same may be communicated to the Commission immediately to enable the Commission to take a decision in the matter.

Candidates are also advised to bring Black Ball Point Pen to the examination hall.

CANDIDATES ARE ADVISED NOT TO BRING ANY ITEM EXCEPT THOSE REQUIRED FOR THE PURPOSE OF EXAMINATION, e.g. ADMIT CARD, ID PROOF, PHOTOGRAPH ETC.

CARRYING / USING ANY TYPE OF CALCULATORS, MOBILE PHONES, GADGETS OF COMMUNICATION IS COMPLETELY BANNED INSIDE THE PREMISES WHERE THE EXAMINATION IS BEING CONDUCTED. INFRINGEMENT OF THIS INSTRUCTION WILL ATTRACT PENAL ACTION INCLUDING BAN FROM FUTURE EXAMINATIONS. CANDIDATES ARE ADVISED IN THEIR OWN INTEREST NOT TO BRING ANY OF THE BANNED ITEMS INCLUDING MOBILE PHONES / PAGERS OR ANY VALUABLE / COSTLY ITEMS TO THE VENUE OF THE EXAMINATION AS ARRANGEMENT FOR SAFE KEEPING CAN NOT BE ASSURED. COMMISSION WILL NOT BE RESPONSIBLE FOR ANY LOSS IN THIS REGARD.

THERE WILL BE AN ARRANGEMENT FOR FRISKING OF THE CANDIDATES AT THE ENTRY POINT OF THE VENUES.
