Notice to the Candidates for inviting objection on answer key for the post Female Constable(GD) against Advt.No.04/2020 Cat.No.02 of Police Department, Haryana

In continuation to earlier notice dated 22.09.2021 regarding inviting objection of answer key for the post of Female Constable (GD) against Advt.No.04/2020 Cat. No.02 of Police Department, it is intimated that written examination for recruitment of above mentioned post was conducted on 18.09.2021 (Evening Session) and 19.09.2021 (Morning/Evening Session) by the Commission.

Candidates who have already filed objection from 24.09.2021 to 26.09.2021 shall submit the objections again as the candidates have not filled correct question booklet series.

All candidates must submit the objections again as objections already filed from 24.09.2021 to 26.09.2021 via notice dated 22.09.2021 will not be considered.

The candidate may now submit his/her objection from 27.09.2021 to 29.09.2021 upto 5.00 P.M. Thereafter no objection will be entertained by the Commission. The candidates are advised to clearly/specify the objection along with name of the Post, Advt. No., Category No., Date of Examination, Set Code, Shift/Session and question no. on which the objection is raised otherwise objection will not be considered. The objections shall be considered by the Commission and its decision in this regard shall be final and evaluation of the paper shall accordingly be done.

The Commission has uploaded the answer key, on the website of the Haryana Staff Selection Commission i.e. www.hssc.gov.in. of the above said written examination. If any candidate has any objection regarding any answer, he/she may submit his/her query/objection. The candidate need to follow the steps given below:

1. Go to www.hssc.gov.in.
2. Click on "Inviting Objection for answer key (Cat. No. 02 , Advt. No. 04/2020)" button.
3. The objection raised by any candidate by any other means will not be entertained.

Further the commission hereby notifies that while evaluating OMR answer sheets the Commission on the advice of Indian Statistical Institute shall adopt percentile method of normalization as the examination was held in multiple shifts and the chief examiner were different. Therefore result shall be prepared on basis of percentile of marks obtained by candidates as per normalization process suggested by Indian Statistical Institute.
