## NOTICE NO. 1231 JUNIOR STENOGRAPHER (ENGLISH) (POST CODE 94/20) IN DELHI TOURISM & TRANSPORTATION DEVELOPMENT CORPORATION LTD.

- The DSSSB vide its Advertisement No. 05/2020 with closing date 27/02/2020 had advertised 02 vacancies (UR-02) for the post of Junior Stenographer (English) in Delhi Tourism & Transportation Development Corporation Ltd. (DTTDC) under Post Code 94/20. Board Conducted Tier-I written examination for recruitment in respect of this post on 19/04/2021.
- 2. On qualifying Written Examination, vide Notice No. 1189 dated 09/07/2021, the DSSSB has shortlisted 52 candidates for appearing in Skill Test/Shorthand Test and Typing Test for the post of Junior Stenographer under Post Code 94/20. The Skill Test was conducted on 18th August, 2021 (Total 01 day) wherein out of 52 candidates, 37 candidates appeared for the test. In the Skill Test conducted, out of 37 candidates only 01 candidate could qualify.
- 3. In evaluation of the shorthand skill test answer sheets of candidates, the Board has considered/condoned up to 7% mistakes for UR category candidates, as qualified with a speed of 100 w.p.m.
- 4. As per RR of the Post the candidate was to Qualify 40 w.p.m. in Typewriting in English, as well.
- 5. The roll number of 01 candidate who has qualified both Shorthand skill test and Typewriting skill test separately and therefore considered qualified Skill Test under Post Code 94/20, is as under:-

6. Based on the performance in the written examination and being qualified in Skill Test of post code 94/20, only one (01) candidate (UR-01) who qualified both, the typewriting skill test as well as Shorthand Skill Test as per details given below is being provisionally shortlisted and accordingly allowed to up-load e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidate in his online application form.

- 7. The shortlisted candidate for the above-mentioned post/post code is hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/Professional/Experience Certificates/Degree and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in his individual account in OARS module. Short listing is being made on the basis of marks obtained in Tier-I examination (Objective-MCQ) for 200 marks and being also qualified in skill test.
- 8. Kindly note that the e-dossier link will be activated only to the candidate who is provisionally shortlisted to upload e-dossier as per details given in para 7 above.
- 9. The candidate who has been shortlisted for falling in consideration zone of selection MUST upload his all requisite/applicable documents in the said link in stipulated time.
- 10. The e-dossier link shall be active from 14/09/2021 to 28/09/2021. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of Closing date of application, i.e., 27/02/2020.
- 11. The above shortlisted candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID as an additional facility. If any candidate fails to upload the e-dossier during their above said period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 12. The candidate who has been shortlisted for uploading e-dossiers MUST upload his all requisite/applicable documents in the said link in stipulated time i.e., 14/09/2021 to 28/09/2021.
- Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his candidature will be treated as cancelled.
- 14. The above short listing of candidate for calling of e-dossier for the post code -94/20 will be subject to outcome of pending court cases, if any.
