#### **Written Examination – Declaration of the Results**

The Written Examination pertaining to the Notification issued on 4<sup>th</sup> July 2021 for direct recruitment of Assistant Public Prosecutors by the Telangana State Level Police Recruitment Board was conducted on 24<sup>th</sup> October, 2021 (Sunday), in 6 Centres in and around Hyderabad City.

Preliminary Key for the Objective Test (Paper I) was made available on the official website: [www.tsiprb.in](http://www.tsiprb.in) from 24-10-2021 onwards. Candidates were given an opportunity to submit Objections on the Preliminary Key till 2 pm on 26-10-2021. After resolving all such Objections and related issues, the Final Key has been arrived at, which is now made available on the Home Page of [www.tsiprb.in](http://www.tsiprb.in). Scanned Copies of Individual OMR Sheets of (Paper-I) Objective Paper of the Candidates are made available in the respective login areas.

The results of Written Examination have been declared and the Result Sheet of each Candidate is made available in the respective login areas. Qualified Candidates have to additionally download the Certificate Verification Intimation Letter and keep it ready. #### **Certificate Verification on 1<sup>st</sup> December at TS Police Academy**

Verification of the Certificates of all those Candidates who qualified in Written Examination (both Paper I and Paper II) will be conducted between 10 a m and 4 p m at JOM Annexe, RBVRR [Telangana State Police Academy](http://www.tsiprb.in), Himayat Sagar (APPA / TSPA Junction) Hyderabad. Candidates have to attend the Certificate Verification in person with all Original Certificates and adequate number of photocopies of all the relevant Certificates. In this regard, it may please be noted that Caste / Community Certificates issued by Authorized Authorities of Telangana Government (dated 2<sup>nd</sup> June 2014 or later) alone will be accepted. Candidates have to wear a mask and shall abide by the Covid-19 precautions throughout the duration of the process. If any Qualified Candidate fails to attend the Certificate Verification as designated, then it will be presumed that he / she is not interested and the Board will take further necessary action.

## **Documents to be brought for Certificate Verification**

- 1) Print-Out of the Application Form submitted by the Candidate Online
- 2) Written Examination Result Sheet
- 3) Intimation Letter of Certificate Verification (to be downloaded)
- 4) Aadhaar Card
- 5) Secondary School / Matriculation or equivalent Certificate in support of the date of birth
- 6) Educational Qualification Certificate/s (Bachelors Degree + LLB / BL Degree)
- 7) Certificate issued by the Bar Council of the State of Telangana / any State or Bar Council of India regarding enrollment as Advocate
- 8) Certificate(s) of active practice for not less than three (3) years in Criminal Courts in the State of Telangana issued by the local Bar Association(s) / Presiding Officer of the concerned Court(s) where the Candidate practiced
- 9) Study Certificate issued by the Government School Authorities / Government recognized School Authority (from 1<sup>st</sup> to 7<sup>th</sup> classes) or Residence Certificate issued by M R O (in case where the Candidate has not studied in any educational institution) for last 4 / 7 years stay prior to completion of 7<sup>th</sup> Class
- 10) Community Certificate issued by Government of Telangana (on or after 2<sup>nd</sup> June 2014)
- 11) Non-Creamy Layer Certificate issued by the Competent Authority issued on or after 1<sup>st</sup> April, 2020 (in case of OBC Candidates)
- 12) Certificate of Economically Weaker Section category issued by the Competent Authorities wherever applicable
- 13) Orthopaedically Handicapped Certificate from the Superintendent, Government General Hospital / Superintendent of District Headquarters Hospital (in case of OH Candidates)
- 14) Meritorious Sports Person Certificate (Form-I for representing India in an International Competition / Multinational Competition in one of the recognized Games/ Sports)
- 15) NCC Instructor Certificate (*for age relaxation*)
- 16) Service Certificate (In case of Telangana State Government Employee) (*for age relaxation*)
- 17) Discharge Certificate of Army / Navy / Air Force (*for age relaxation*)
- 18) Any other relevant Certificate/s
