APPRENTICESHIP OF LINEMAN

Punjab State Power Corporation Ltd., a power generating and distributing organization of Government of Punjab is inviting application for the Apprenticeship Training of Lineman from the candidates who have completed ITI in WIREMAN/ELECTRICIAN trade. Preference will be given to Punjab resident/domicile candidates and if above candidates are not available, the other state candidates will be considered.

- 1) Name of the Apprenticeship : Lineman
- 2) No. of Seats : 600
- 3) Stipend : As per Apprenticeship Act 1961 and Apprenticeship Rules 1992) as amended from time to time.

Note:- Seats may increase / decrease as per the requirement of PSPCL.

Detail of 600 Seats is as below :

4. **QUALIFICATION:**

Candidates shall be ITI in WIREMAN or ELECTRICIAN Trade. The certificate should be duly issued by NCVT/SCVT.

5. **AGE LIMIT:**

As per Apprenticeship Act 1961 (Apprenticeship Rules 1992) as amended from time to time.

6. **PERIOD OF TRAINING :**

One Year (as per Apprenticeship Act 1961, Apprenticeship Rules 1992 as amended from time to time).

7. **RESERVATION OF POSTS :**

The reservation of posts is indicated in the table above as per provision of Apprenticeship Act 1961 and approved by PSPCL. The reservation is applicable to candidates of Punjab domicile/resident only.

- (i) SC/BC (Scheduled Caste/Backward Class) Certificate as per the instructions of the Concerned department of Govt. of Punjab.
- (ii) PWD (Person with disability)
PD (Partial Deaf) The PWD certificate with permanent disability shall be issued by Civil Surgeon of Govt. of Punjab.

- (iii) All reserved category candidates are required to produce Punjab Domicile issued on or after 01-01-2021.
- (iv) As per the latest amendment made by the Ministry of Law and Justice (Legislative Department) in "THE RIGHTS OF PERSONS WITH DISABILITY ACT 2016" which have been further adopted by Govt. of Punjab vide memo no. 1/1/2017/3dc-1543557/1 dated 06-08-2019, reservation for Person with disability has been increased from 3% to 4%.

NOTE: : PWD- Person with Disability (The reservation is for Partial Deaf only)

8. **SELECTION PROCESS:**

Selection will be based purely on merit basis .The merit will be made as per marks obtained in ITI of Wireman or Electrician trade. The percentage marks obtained shall be rounded off to nearest 2nd decimal digit for preparing the merit. No weightage shall be given for higher qualifications.

9. **DOCUMENT CHECKING PROCESS:**

On the basis of merit list candidates shall be called for document checking .Verification of original documents /certificates would be conducted by document checking committee , for which dates shall be notified later through registered e-mail ID's (as mentioned by the candidate in his/her online application form) and on PSPCL's website (www.pspcl.in) only.Thus candidates are advised to mention their e-mail ID's very carefully.

Note:-

- 1) It is further clarified that mere calling of any candidate for document checking doesn't entitle him/her for selection/admission to the said post.
- 2) Candidate shall be notified about venue, date and time of document checking through Registered e-mail ID of candidate (as mentioned by the candidate in his/her online application form) and on PSPCL's website (www.pspcl.in) only. In case candidate does not appear on the 1st scheduled date , then 2nd and final chance would be given to such candidate and in acse he/she again fails to appear for document checking even on 2nd and final chance, than no further chance would be given & his/her candidature shall be cancelled/forfeited without any further notice.
- 3) Candidate has to himself/herself appear for the process of document checking. Nobody on candidate's behalf can appear in the document checking.
- 4) Educational qualifications must be from Recognized Institution.

10. **GENERAL INSTRUCTIONS:**

- (i) The PSPCL reserves the right to decrease/increase the number of Seats advertised without any notice .PSPCL reserves the right to call the final selected candidates once put up on the merit list, as per the number of actual seats available.
- (ii) The candidate must possess the prescribed qualifications as per para-4 including reservation certificate up to the last date of online registration. The candidates whose results have been officially and publically declared till the last date of online registration shall only be eligible to apply.
- (iii) **Selected candidate/Apprentice has to register on the portal before joining the allotted station as Apprentice Lineman in PSPCL.**
- (iv) Candidate who has already done ITI Apprenticeship earlier in any other department or in PSPCL will not be eligible for this Apprenticeship.
- (v) Every apprentice must have an Adhar Number/any other prescribed document.
- (vi) Candidates are advised to keep the e-mail id to be entered compulsorily in the online application form and the same should remain active for the entire training period. No change in the e-mail id will be allowed once entered.
- (vii) In case of any ambiguity/dispute or interpretation, decision of the PSPCL shall be final and binding on the candidates. Legal jurisdiction shall be subject to Local Courts at Patiala only.

- (viii) **No manual/paper application will be entertained.**
- (ix) Certificates in support of reservation of seat must have been obtained on or before the last date of registration of applications. Any certificate issued after this date shall not be entertained. Candidates shall submit the attested copy of these certificates /documents at the time of checking of original documents.
- (x) **It should be clearly understood to the candidate that during the entire period of Apprenticeship, his posting place will not be changed under any circumstances.**
- (xi) **It is informed NO CORRIGENDUM will be published in newspapers in this regard. Details regarding corrigendum if any may be seen on PSPCL website www.pspcl.in.**
- (xii) On successful registration of online application, candidates are advised not to attempt for re-registration for the same post since multiple registration number and password may create problem for candidates in future . In case of multiple registrations for the same post, the candidature is liable for cancellation/rejection without any notice/intimation to the candidate.
- (xiii) Candidates in their own interest are advised, not to wait till the last date & time and register their application well within the time. PSPCL shall not be held responsible , if the candidates are not able to submit their application due to last time rush.
- (xiv) PSPCL does not assume any responsibility for the candidates not being able to submit their applications within the last date on account of the aforesaid reasons or for any other reason, whatsoever.
- (xv) Candidates are also advised to keep copy of application form with them for reference and record.
- (xvi) Please note that the above procedure is the only valid procedure for applying. No other mode of application will be accepted.
- (xvii) **Candidate should note that his/her candidature is purely "PROVISIONAL" subject to eligibility verification during document checking .Before submitting the application , the candidate must ensure that he/she fulfills all the eligibility criteria as laid down in this advertisement or amendments if any issued subsequently.**
- (xviii) Candidates should only submit their application online and they are not required to send hard copy of online application form or any certificate to PSPCL separately.
- (xix) The decision of the PSPCL about the mode of selection to the post and eligibility conditions shall be final and binding .No correspondence will be entertained in this regard.
- (xx) No TA/DA will be paid for the journeys performed for the documents checking etc.
- (xxi) All information including qualifications , category, age etc. declared by the candidate in their application is presumed to be correct subject to its verification later on in respect of those eligible candidates who may be called for document checking before their admission for joining PSPCL. There is no mechanism to verify the information/data during the online application. If, at any stage (during document checking before issue of admission letter or even after his/her joining the PSPCL), any information of the candidate is found to be wrong/forged/bogus , the candidature of such candidate will be cancelled ab initio and action will be taken against him/her according to law.
- (xxii) The selected candidates will be governed by PSPCL Rules & Regulations amended from time to time.

11. HOW TO APPLY

- (i) Candidates are required to apply online through PSPCL website (www.pspcl.in) in English only.
No other means/mode of submission of applications (including hand written application) will be accepted under any circumstances.
- (ii) Candidates should have a valid personal e- mail id.It should be kept active during the entire training period.
- (iii) Candidates should take utmost care to furnish the correct details while filling in on-line application. Any mistake committed by the candidate shall be his/her sole responsibility. **No subsequent corrections/modifications are allowed once the online application is registered.**

(iv) Before starting to fill up the on- line application, make sure the following details/documents are readily available with the candidate:-

- a) Matriculation Certificate for personal details.
- b) Punjabi Pass Certificate at Matriculation Level
- c) ITI Pass Certificate/Detail Marks sheet in Electrician/Wireman trade
- d) Aadhar Card
- e) Reserve Category Certificate (if applicable)
- (v) To apply visit PSPCL website www.pspcl.in under RECRUITMENT Link, click on APPRENTICESHIP TRAINING OF LINEMAN. TRAINING OF LINEMAN.
- (vi) To apply click on New Registration:-
 - a) Fill up all the information desired in the form correctly.
 - b) Upload recent photo in JPEG format maximum size 20-50 KB
With dimension (150*200)
 - c) Upload Signature in JPEG format maximum size 10-20 KB
With dimension (140*60)

Note the Registration number for future correspondence.

(vii) PSPCL does not take any responsibility for the candidates not being able to register their applications upto the last date due to any reason.

(viii) His/Her candidature will be purely provisional subject to eligibility verification during document checking.

(ix) The decision of the PSPCL about the mode of selection to the post and eligibility conditions shall be final and binding. No correspondence shall be entertained in this regard.
