For validity of the sports achievement, concluding day of championship/event shall be taken into account. Further, activeness in sports will be adjudged as per his performance during the trials.

All the recruitments shall be at the minimum of scale of Pay.

All the championships mentioned above, conducted under the aegis of recognized International/National/State Sports Federation and also recognized by the Railway Sports Promotion Board will only be acceptable.

Sportspersons having sports norms for higher Levels of pay and apply against the vacancies for the lower Levels of pay, will also be considered, provided he will not claim for higher Level after joining the Railways on the basis of sports achievements prior to joining Railways and the candidate gives an undertaking to this effect.

#### 6. (I) <u>SELECTION PROCEDURE</u>:

- i) For this Recruitment, all eligible candidates will be called for the trials. Trials of the eligible candidates shall be conducted to assess the sports performance and suitability.
- ii) The dates for trials will be notified later and published in the South Western Railway website and will be held at Hubballi/Bengaluru/Mysuru or at notified place. While all out efforts will be made to inform the candidates well in advance, the candidates are cautioned that they may have to appear in the selection trials at short notice. The candidates are advised to regularly check the website for information in this regard.
- iii) Candidates should note that they are required to produce the originals of all documents uploaded while filling online application pertaining to educational qualification, caste, sports achievements, date of birth, minority income certificate and proof of identity viz. PAN card, Aadhar Card, Driving Licence etc. on the day of document verification and on the day trials failing which, the candidate will not be allowed to appear in the trials.
- iv) South Western Railway will upload the list of eligible candidates selected for trials in South Western Railway website <a href="www.rrchubli.in">www.rrchubli.in</a> In addition, communication will also be sent by SMS/Email id as shown in the application, to the eligible candidates for appearing in the selection trials.
- v) Any request for change in dates/venue for trials etc **shall not be entertained** under any circumstances.

#### Note:

- i) The Processing Fee should be paid ONLINE using internet banking or debit/credit cards (service charges apply for all banks which shall be borne by the candidates).
- ii) The Processing Fee is not refundable/transferable/adjustable under any circumstances, in respect of those candidates who do not fulfil the eligibility criteria but still have applied for recruitment, in response to this notification.
- iii) Certificate in proof of para 7 (b) above, issued by the authorities authorized to issue such certificate should be uploaded while filling the online application form for getting relaxation in the Processing Fee. Candidates should check their eligibility thoroughly before applying. Processing Fee paid in respect of candidates who are ineligible, but still apply, shall not be refunded.

  - (b) Sitting Member of Parliament of Lok Sabha for persons of their own constituency.

- (c) BPL card or any other certificate issued by the Central Government under a recognized poverty alleviation programme or Izzat MST issued by Railways.
- (d) Union Minister may also recommend for any persons from anywhere in the Country,
- (e) Sitting Members of Parliament of Rajya Sabha for persons of the district in which these MPs normally reside.
- (f) The income certificate issued by the authorities mentioned above would have to be in the format prescribed at 'Annexure D'. This would have to be issued on the letter head of the issuing authority.

#### 8. <u>MEDICAL EXAMINATION</u>:

The sportsperson/s selected shall fulfil the minimum medical norms for the post, for which they are being appointed.

#### 9. "SERVICE BOND" FOR PERSONS RECRUITED AGAINST SPORTS QUOTA:

The "Service Bond" period for the persons recruited against Sports Quota shall be of five years. At the time of his appointment, the sports persons shall fill and sign the Bond in the format as at 'Annexure - E' to this notification. In terms of provision of para 3 of 'Annexure - E' (Service Bond) those recruited against sports quota can participate in any of the sports activities other than those of the Government including professional Games/Leagues only with previous sanction of the Government.

  - (d) Payment of processing fees.
- (b) Visit the website: www.rrchubli.in  $\Longrightarrow$  Recruitment against Sports Quota (OA) for the year 2021-22.
- (c) Candidates can view and download detailed notification available in the web page before applying.
- (d) Click on the "ONLINE APPLICATION" for Sports Quota (Open Advertisement) recruitment for the year 2021-22" link.
- (e) Click on the "New Registration".
- (f) Candidates will be redirected to **Registration page** wherein they have to enter Name, valid mobile number, E-Mail ID. Enter the OTP received and click on "SUBMIT".
- (g) An User ID & password will be sent to the registered provided mobile number, E-Mail ID which has to be preserved till the finalisation of selection process.
- (h) Candidates will be directed to login page wherein the User ID & Password has to be entered for submission of application.

- (i) Fill in the details i.e. address, community (SC/ST/OBC/UR), if belongs to Minority/Economically Backward Class, Educational Qualification, Sports achievement.
- (j) In next page candidate has to upload recent colour photograph of size 3.5 cm X 3.5cm (not older than three months from the date of application) with clear front view of the candidate without cap and sunglasses should be uploaded. The photo should be only in JPEG format, upload specimen signature as per the specifications mentioned in the website.
- (k) Also upload the following certificates:
  - (i) Certificate in support of Date of Birth.
  - (ii) All the required educational certificates (in one PDF).
  - (iii)Sports achievements certificates for the period between 01.04.2019 and 11.02.2022 (All sports achievement certificates are to be uploaded in one PDF) as per the specifications mentioned in the notification.
  - (iv)Community certificate/Self declaration of Minority candidates/ECB/NOC, etc.
- (j) After uploading submit after which all the details entered/uploaded by the candidates will be displayed. If there are any changes to be made, candidates can click on "EDIT" button to complete the changes or they can process for payment by clicking "Payment of fees".

#### 13. <u>INVALID APPLICATIONS</u>:

- (i) Application without scanned Photo.
- (ii) Applications without proof of age i.e. Date of Birth as recorded in the Birth certificate.
- (iii) Applications of over-aged and under-aged candidates as on the cut-off date and also where Date of Birth certificates uploaded are illegible, date not filled in or wrongly filled.
- (iv) Not having the requisite Educational Qualification as on the date of issue of notification.
- (v) Application without Caste Certificate/self declaration by minority candidates/ECB, etc. wherever fee relaxation is claimed in case of SC/ST/Minority/ECB candidates.
- (vi) Application without uploading the requisite certificates for eligibility.
- (vii) Applications which are incomplete in any manner, including non-filling up of requisite fields, etc.
- (viji) Any other form of irregularities as observed and considered as invalid.
- (ix) Before applying for a post, the candidates should ensure that, they fulfil the eligibility criteria stipulated for the post as per the sports norms. The Railway Administration would be at liberty to reject any application not fulfilling the prescribed criteria at any stage of recruitment.
- (x) Applications without uploaded signature (Signature should not be in capital letters).
- (xi) Applications submitted in any other mode other than Online (No physical applications will be accepted).

#### 14. **GENERAL CONDITIONS**:

- (a) Canvassing in any form shall disqualify the candidature.
- (b) Candidates are advised to indicate their active mobile number and valid e-mail ID in the application form and keep them active during the entire recruitment process as all important messages will be sent by e-mail/SMS which will be treated as deemed to have been read by the candidate.
- (c) The Eligible candidates will be subjected for Trials, which will be advised through SMS/Email. Call letters for the same have to be downloaded from the RRC website and no separate letter will be sent through post.
- (d) Candidates are advised not to bring any valuable/costly items at the time of trials, as safe-keeping of these items cannot be assured.
- (e) Applicant should possess the prescribed minimum educational qualification and sports achievements on the date of issue of notification.
- (f) Candidates may download the recruitment notification available on Railway Recruitment Cell, South Western Railway website **www.rrchubli.in**
- (g) South Western Railway administration reserves the right to alter the stages of recruitment or cancel part or whole or any recruitment process at any stage without assigning any reason.

- (h) The number of vacancies indicated in this notification is provisional and may decrease or even become NIL at a later stage depending upon the actual needs of the Railway Administration.

- (j) While all out efforts will be made to inform the eligibility of candidates for trials well in advance, the candidates are cautioned that they may have to appear in the selection trials at short notice. The candidates are advised to regularly check the website www.rrchubli.in
- (k) Candidates may please note that mere calling for trials will not guarantee appointment of candidates against sports quota.
- (l) All the candidates getting appointed through sports quota will undergo probation period of 2 years. Before completion of probation period, the performance of the sportsperson shall be reviewed at the Railway/Unit Level by a committee constituted for the purpose. If the performance is considered to be unsatisfactory, the probation period will be extended and in case performance is not found up to the mark, their services are liable to be terminated.
- (m) Candidates selected through sports quota will have to perform in his field of sports for a minimum period of 5 years. The selected candidates will have to execute a service bond in the prescribed format ('Annexure E' to the notification) at the time of appointment.
- (n) The decision of South Western Railway Administration in all matters relating to eligibility, acceptance or rejection of the application, penalty for false information, mode of selection, conduct of trials, selection, allotment of post to selected candidates etc. will be final and binding on the candidates.
