Example:

(Ms) No.28, Welfare of Differently Abled Persons (DAP 3.1), dated 27.07.2018.

- **(G)** If no qualified and suitable women applicants are available for selection against the vacancies reserved for them, those vacancies will be filled by male applicants belonging to the respective communal categories. [Section 26(5) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016].
- (H) Wherever vacancies are reserved for Arunthathiyars on preferential basis, even after filling the vacancies reserved for SC (Arunthathiyars) on preferential basis, if more number of qualified Arunthathiyars are available, they shall be entitled to compete with the Scheduled Castes other than Arunthathiyars in the inter-se-merit among them and if any posts reserved for Arunthathiyars remain unfilled for want of adequate number of qualified applicants, it shall be filled by Scheduled Castes other than Arunthathiyars.

- (i) Except the permitted writing material (Black ball point pen), applicants are not allowed to bring cellular phones, electronic or any other type of calculators, watches and rings with inbuilt memory notes, recording devices either as a separate piece or part of something used by the applicant such as watch or ring etc., or any other electronic devices and non-electronic devices such as P&G design data book, mathematical and drawing instruments, log tables, stencils of maps, slide rules books, notes, loose sheets, rough sheets, hand bags etc., into the examination hall / room.

In the Government Order first read above, orders were insued reserving 3% of vacancies in Government and Government undertakings for Differently Abled Persons.

- In the Government Order second read above, reservation of 3% vacancies has been provided for physically handicapped persons to the Executive post in respect of 'C' and 'D' categories.
- 3 In the Government Order fourth read above orders were issued for increasing the percentage of reservation of differently abled persons in employment from 3% to 4% in all State Public Services / Public Sector Undertakings / Boards / Corporations / Educational Institutions under all kinds of Managements (like Government, Local Bodies and Aided Management including Universities).
- 4. In the Government Order lifth read above an expert committee has been formed for identification of posts suitable for differently abled persons in employment in respect of group 'A', 'B', 'C' and 'D' categories as per section 34 of the Rights of Persons with Disabilities Act, 2015.
- 5. In the letter eight read above the State Commissioner for the Differently Abled has submitted proposals based on the recommendation of the Expert Committee that 4% reservation of posts earmarked for the differently abled persons shall be applicable as earlier to all the posts in respect of 'C' and 'D' categories. He has also stated that the provise to Section 34(1) of the Rights of Persons with Disabilities Act. 2016 gives power

to the Government to exempt any establishment from the 4% reservation. If any department / establishment is of the view that any particular post in 'C' and 'D' category is not suitable for differently abled persons, in such case, it may specifically apply to the Government in the administrative department in consultation with the State Commissioner for the Differently Abted and the Government shall issue appropriate orders. Further he has requested the Government to issue appropriate orders in this regard.

 After careful examination of the proposal of State Commissioner for the Differently Abled, the following orders are issued:

 the reservation of 4% vacancies earmarked for the differently abled persons will be applicable to all the posts in respect of 'C' and 'D' categories in employment.

(ii) the reservation of 4% vacancies for differently abled persons need not be made applicable in the case of recruitment by transfer/promotion as it would amount to giving double preference to these candidates.

(iii) If any department / establishment is of the view that any particular post in 'C' and 'D' category is not suitable for differently abled persons, in such case, it may specifically request the Government for exemption. The administrative department in consultation with the State Commissioner for the Differently Abled and the Government shall issue appropriate orders.

(iv)the individuals selected for "C" and "D" categories of posts should be asked to produce certificate of physical fitness and the disability certificate as stated in section 3(oo) of Tamil Nadu Government Servants (Conditions of Service) Act.

As per section 33(i) of the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2015) 'the appropriate Government shall identify posts in the establishments which can be held by respective category of persons with benchmark disabilities in respect of the vacancies reserved in accontance with the provisions of section 34" of the said Act.

- 3 in the Government order second read above, 263 posts under group A & B category were identified as suitable for differently abled persons under 3% reservation, in the Government order third read above Government have issued orders for increasing the percentage of reservation of differently abled persons in employment from 3% to 4%.
- In the Government order lifth read above, on Expert Committee for identifying Groups 'A', B', 'C' and 'D' posts have been committuted as per section 33(i) of the Rights of Persons with Disabilities Act, 2016.
- 5. In the Government order fourth read above, in Group 'A' and 'B' categories three posts like Civil Judge and District Judge (entry level), Post Graduate Teacher and Physical Director (Grade-I) were identified, in the Government order sixth read above certain amendment was made for the Civil Judge and District Judge (entry level) and in the Government order seventh read above. Paraonal Assistant to Hon'ble High Court Judge, Interpreter and Senior system analyst were identified for most suitable for differently abled persons.
- 6. In the letter eight read above, the State Commissioner for the Differently Abled has sent proposals for identifying posts suitable for differently abled persons under Group 'A' and 'B' categories based on the opinion of the Expert Committee for consideration.
- 7. The Government after careful examination of the proposal of the State Commissioner for the Differently Abled, in consultation with all the concerned departments have decided to approve 229 posts under 'A' and 'B' categories and six posts already identified in Government orders 5th, 6th and 7th read above. Totally 235 posts under Group 'A' and 'B' categories are most suitable for differently abled persons. In respect of posts comes under other departments, boards and corporations will be identified and issue orders separately.
- 8. The Government also direct that 4% of the vacancies in direct recruitment for the identified posts in 'A' and 'B' Groups, where the rule of reservation is applicable for the SGs / STs / BCs and other communities, shall be reserved for the Differently Abled Persons. If only one post is available for recruitment in these categories, the usual procedure for recruitment will be followed. The Government has also directed that.
 - (i) The reservation of 4% vacancies earmarked for the differently abled persons will be applicable to indentified posts in respect of 'A' and 'B' categories for direct recruitment posts only.
 - (ii) The reservation of 4% vacancies for differently abled persons need not be made applicable in the case of recruitment by transfer/promotion as it would amount to giving double preference to these candidates.
 - (iii) If any department / establishment is of the view that any particular post in 'A' and 'B' category is not suitable for differently abled persons, in such case, it may specifically request the Government for exemption. 


