- (a) **Eligibility Criteria -**
- i) The minimum education qualification is B.P.E. 3 years/4 years course/Degree with B.P. Ed or equivalent.
 - ii) The age of candidates should not be more than 38 years and not less than 18 years of age on 01-01-2022. The Upper age limit for STSC candidates is relaxable as per Govt. Rules and Documents like affidavit etc. shall not be accepted as proof of age.
 - iii) Candidates having sportsman skills and at least 3 (Three) years working experience will be given preference. - (a) **Eligibility Criteria -**
- i) The minimum education qualification is Graduate in Bachelor degree from a recognized University with 1 (one) year Diploma in Sports Coaching from Netaji Subhash National Institute of Sports (NISNS) or its equivalent post graduate diplomas/certificates in coaching from any other institute recognized by the Ministry of Youth Affairs and Sports, Government of India.
 - ii) The age of candidates should not be more than 38 years and not less than 18 years of age on 01-01-2022. The Upper age limit for STSC candidates is relaxable as per Govt. Rules and Documents like affidavit etc. shall not be accepted as proof of age.

- (a) **Eligibility Criteria -**
- i) The minimum education qualification is B.P.E. 3 years/4 years course/Degree with B.P. Ed or equivalent.
 - ii) The age of candidates should not be more than 38 years and not less than 18 years of age on 01-01-2022. The Upper age limit for STSC candidates is relaxable as per Govt. Rules and Documents like affidavit etc. shall not be accepted as proof of age.
 - iii) Candidates having sportsman skills and at least 3 (Three) years working experience will be given preference. The eligible candidates applying for the post of Physical Instructor (PI) will have to appear for a PET (Physical Eligibility Test) and Oral Interview as per the marks given below which will be on 24th & 25th March, 2022 at SAI, SAG Centre, Katholjuri, Kokrajhar BTR.

General Instructions:

- i) **How to Apply:** Eligible candidates willing to apply for the above mentioned posts may apply by filling up the Standard Application Form of this advertisement. The candidates who are in Govt. Service or Public undertakings or other similar Organizations/Corporations/Bodies or in Private Employment must apply through proper channel and should ensure receipt of further application of the Board's office within the stipulated date of receipt of application failing which he/she is liable to be rejected. No advance copy of application shall be treated as valid for determination of eligibility of a candidate.
- ii) Candidates only from Bokoland Territorial Region (BTR) need to apply for the posts of SDSO & Physical Instructor but for the post of Coach, candidates from outside BTR can apply however for the same candidates from BTR will be given 1st preference.
- iii) **Fee:** All candidates applying for the above mentioned posts to be deposited a Treasury Challan (Payable Through Kokrajhar Treasury Office) only to the amount of Rs. 1000 (Rupees One thousand only) for General & Category of STSC Candidates of Rs. 500 (Rupees Fifty only) in favour of the Principal Secretary of BTC under the Head of Account 5443 Civil Deposit, Personal Deposit BTC, payable at Kokrajhar. The Treasury Challan and a Kokrajhar Treasury Office only that be accepted and all the candidates other than Kokrajhar may submit IPO (Indian Postal Order) of the same amount issued of Treasury Challan along with their application.
- iv) **Documents:**
 - a) The applicant must furnish 6 (six) copies of recent identical photographs signed across and one copy must be pasted on the top right hand corner of the application.
 - b) Educational qualification certificate from HSLC onwards.
 - c) Cast Certificate by Competent Authority.
 - d) Valid Registration Certificate of Employment Exchange.
 - e) Declaration in Form A related to the Assam Public Service (Application of Small Family norms in Direct Recruitment) Rules, 2018, published vide Notification No. A.B.F. 06/2019/D dated Dispur, on 09th November, 2019. Candidates may download the specimen copy of the Certificate from personnel.assam.gov.in
 - f) Professional & experience Certificate if any need to be furnished. However attestation of the certificates is not compulsory and the candidate may signed himself/thereof as certified to be true copy.
- v) **Examination/Interview:** The Candidates applying for the above mentioned posts will have to appear for a PET (Physical Eligibility Test) and Oral Interview at their own expenses as per posts wise date and venue mentioned above.
- vi) **Reservation:** Reservation will be as per Sixth Schedule norms.
- vii) **Last date of receiving application is fixed on 19th March, 2022.**
- viii) The application form duly filled up by the candidate himself/herself along with completed questionnaire should be submitted to "The CHD, Sports & Youth Welfare, BTC, Kokrajhar, Tezpur, BTR, Assam Pin-781037" by hand on or before 19th March, 2022 (Saturday) during office hours and no application will be received by post.
- ix) Admit Card will be issued on 27th March, 2022 from 11:00 A.M. On Admit Card will be sent through by post.
- x) The envelope containing application along with completed questionnaire and self-addressed envelope (size 23 x 10 mm) affixing five rupees postal stamp must be clearly subscribed the name of post applied for on the Top of the envelope.
- xi) Incomplete applications in terms of advertisement and applications received after the closing date will summarily be rejected.
- xii) The relaxation of age in case of STSC candidates and in Govt. Service is as per Govt. Rules.
- xiii) **Points to be noted -**
 - a) In the overall interview process, if in case of tie in marks, the candidates older in age will be placed higher in the merit list. Further, candidates having same date of birth and have obtained equal marks, the candidate scoring higher marks in the minimum essential qualification for the post will be placed higher in the merit list. In case after following up the methods above for tie/break etc., score criteria arise, the Selection Committee shall decide judiciously in per norms.
 - b) Pension Scheme: Govt. servants joining the service of the State Govt. on or after 1st February, 2003 will be governed by a new set of Pension Rules formulated in the with the contributory Pension Scheme announced by the Govt. of India vide Finance Deptt. Circular No. BW/3003/Ph-I, dated 25.01.2005. An undertaking shall have to be executed in this regard.
 - c) The candidates before applying for the posts (see/viz) should ensure that they fulfill all the eligibility conditions. Their admission at all the stages of selection in which they are admitted by the CHD, Sports & Youth Welfare, BTC, Kokrajhar will be purely provisional and under scrutiny, subject to their satisfying the prescribed eligibility conditions. If on verification at any time or any stage before or after test, it is found that they do not fulfill any of the eligibility criteria conditions, then candidates of the posts will be cancelled by the authority.
- xiv) The candidates who furnished wrong/erroneous or incorrect information in their application form may be disqualified from appearing for the post.
- xv) On appointment, the candidates shall be governed by existing Rules and Orders of the Government issued from time to time.
- xvi) The final appointment after selection is subject to satisfactory Non-fraud Affidavit as per OM No. A.B.F. 20/2018/dt. 19th November, 2021. In case Non-fraud Affidavit is found false, the candidates of such candidates will be rejected outright.
- xvii) The candidates selected shall be appointed subject to receipt of Medical Fitness Certificate.
- xviii) Candidates directly or indirectly will be deemed to be appropriate ground for disqualification of the candidate.
- xix) The CHD, Sports & Youth Welfare, BTC, Kokrajhar reserves the right to accept, modify or cancel the Advertisement and to cancel or postpone all test without assigning any reason thereof.
- xx) Incomplete and wrongly filled application form will be rejected and no appeal or correction in that regard shall be entertained.
- xxi) Merely appearing for all tests does not confer any right to claim for appointment.
- xxii) Since the applications are submitted, the question of submission of application through proper channel in case of the candidates already employed becomes redundant. However such candidates shall intimate their appointing authorities about submission of application in writing.
- xxiii) Incomplete application will be rejected without giving any information to the candidates.
- xxiv) The applicants are advised to submit only a single application. However, if due to any unavoidable situation he/she submits another multiple applications, he/she will ensure that the application with the higher registration number is completed in all respect, which will be accepted by the Selection Committee.
- xxv) No TADA shall be provided to the candidates for appearing the selection process.
- xxvi) Decision of the Selection Committee as to the eligibility or otherwise of a candidate for admission to the test shall be final.
