ELIGIBILITY CRITERIA

1. Age as on 01.01.2022- Minimum Age:18 years; Maximum Age 24 years (Candidates born between 02.01.1998 and 01.01.2004 (both dates inclusive) are eligible.

RELAXATION OF UPPER AGE LIMIT: SC/ST candidates by 05 years, SC/ST Physically/Orthopedically Handicap candidates by 15 years, OBC candidates by 03 years, OBC Physically/Orthopedically handicap candidates by 13 years, Physically/Orthopedically handicap candidates by 10 years, Ex-servicemen candidates by 03 years in addition to the length of military service and for children/family members of those who died in the 1984 riots by 03 years. (The maximum age limit of all relaxations combined not to exceed 45 years unless it is so provided in Govt. Directives.)

OBC/SC/ST candidates applying in UNRESERVED quota are not eligible for age relaxation.

2. Educational qualification

Pass in XII Standard (minimum and maximum) with basic reading and writing knowledge of English. The candidates having completed higher qualification/s (i.e. **Graduation and above**) need not apply.

3. Domicile of the district:

The eligible candidates should be the **domicile of that District** for which vacancies have been notified / published.

The candidates who fulfill the above eligibility criteria may send their duly signed application latest by **09.04.2022 by 5.00 P.M by post only**. Application forms should be collected from any of the PNB branches in Trichy Districts. A recent passport size photograph should be affixed on top right corner of the application.

A self-attested xerox copy of following documents should be attached with the application form.

1. Complete Mark Sheets (X and XII Std).
2. Copy of the Transfer Certificate of XII Standard.
3. Copy of Address Proof & ID Proof (PAN Card, Aadhar Card etc).
4. Copy of Nativity Certificate issued by Deputy Tahsildar as a proof of domicile.
5. Copy of Caste Certificate issued by Tahsildar, if any. (In case OBC candidates, latest caste certificate mentioning non-creamy layer clause to be submitted).
6. Employment Exchange registration card, if registered.
7. Copy of disability certificate issued by the Government Medical Board, indicating the percentage of disability, in case of PWD candidates.
8. Copy of discharge book (All pages), PPO, ID Card and LPC, in case of Ex-Servicemen.
9. Copy of birth certificate.
10. Copy of other Certificates, if any.
11. Copy of Income and Asset Certificate if applying under EWS (Economically Weaker section) issued by one of the following Authorities:

District Magistrate/ Additional District Magistrate/ Collector/ Deputy Commissioner/Additional Deputy Commissioner/ 1st Class stipendiary Magistrate/ Sub Divisional Magistrate/ Taluk Magistrate/ Executive Magistrate/ Extra Assistant Commissioner/ Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/ Presidency Magistrate/Revenue Officer not below the rank of Tahsildar / Sub Divisional officer of the area where the candidate and or/his family normally resides.

Last date for submission of Application: 09.04.2022, 5.00 PM

Applications received after 5.00PM on 09.04.2022 onwards / incomplete applications are liable to be rejected. Similarly submitting the enclosures without application / application without enclosures such as X and XII Standard Mark Sheets indicating the marks obtained in all subjects / Address & ID Proof / required documents as mentioned above are also liable to be rejected. The selection of Peons will be on the basis of percentage of marks obtained by the candidates in 10th standard and 12th standard. In case of percentage of marks calculated (up to two decimal points) being equal, the candidates elder in age will be placed higher in the merit list. No communication will be sent to those candidates whose applications are not being considered. The decision of the Bank as regards selection shall be final.
