INSTRUCTIONS TO CANDIDATES OF AP Ed.CET-2022:

A Common Entrance Test, designated as Education Common Entrance Test-2022 (AP Ed.CET-2022) will be conducted by the CONVENER, AP Ed.CET-2022, Department of Education, Sri Padmavati Mahila Visvavidyalayam, Tirupati on behalf of the Andhra Pradesh State Council of Higher Education (APSCHE) for admission into B.Ed. Regular Course and B.Ed. Special Education in the University /Government/ Aided and /Private Colleges of Education in Andhra Pradesh for the Academic Year2022-2023.

I. ELIGIBILITY TO APPEAR FOR APEd.CET-2022:

Candidates satisfying the following requirements shall be eligible to appear for AP Ed.CET-2022.

- (i) The Candidates should be IndianNationals.
- (ii) The Candidates should satisfy Local/Non-Local status requirements as laid down in the Andhra Pradesh Educational Institutions (Regulation of Admission) Order 1974 as subsequently amended.

(iii) Educational Qualifications:

- (a) Candidates should have passed/appearing for final year examinations of B.A./B.Sc./B.Sc. (Home Science)/B.Com./ B.C.A./B.B.M. at the time of submitting the Application for AP Ed.CET-2022. Candidates are required to produce marks memo and pass certificate at the time of admission.
- (b) Candidates should have secured a minimum of **50% marks** either in the Bachelor's Degree i.e., B.A./B.Sc./B.Sc. (Home Science)/B.Com./B.C.A./B.B.M and or in the Post-Graduate Degree in relevant subject or 5 years integrated course in the relevant subject of methodology or any other qualification equivalent thereto. However the candidates belonging to all other reserved categories **S.C**, **S.T**, **B.C.(A/B/C/D/E)**, and physically handicapped should have secured a minimum of 40% marks in the qualifying examination.

Note: The candidates who passed B.E/B.Tech. (with minimum of 55% of marks), with Mathematics, Physics are eligible for admission into the Course.

(iv) Age Limit: The candidates should have completed the age of 19 years on the 1st of July in the year in which notification is issued. There shall be no maximum agelimit.

II. SCHEME OF EXAMINATION FOR APEd.CET-2022:

The common entrance test will be of objective type (multiple choices) examination. Candidate has to answer 150 questions in two hourstime.

- Part-A: General English 25 questions for 25 marks
- Part-B: 1) General Knowledge 15 questions for 15 marks
 - 2) Teaching Aptitude 10 questions for 10 marks

Part-C: Methodology: Candidate has to choose one of the following subjects. It consists of 100 questions for 100 marks.

- 1) Mathematics 100 questions for 100marks
- 2) Physical Sciences 100 questions for 100marks
 - (i) Physics 50 questions for 50marks
 - (ii) Chemistry 50 questions for 50marks
- 3) Biological Sciences 100 questions for 100marks
 - (i) Botany 50 questions for 50marks
 - (ii) Zoology 50 questions for 50marks
- 4) Social Studies 100 questions for 100marks
 - (i) Geography 35 questions for 35marks
 - (ii) History 30 questions for 30marks
 - (iii) Civics 15 questions for 15marks
 - (iv) Economics 20 questions for 20marks
- 5) English 100 questions for 100marks

Note: Part - A and Part - B are common for all the candidates irrespective of Methodology chosen in Part-C.

III. ELIGIBILITY CRITERIA FOR THE CHOICE OF SUBJECT UNDER PART-C:

(G.O.Ms.No. 92, Education (SE-Trg-I) Department, dated 16-11-2006 and the amendments thereafter).

METHODOLOGY ELIGIBILITY:

- **1. Mathematics:** Candidates with B.A/B.Sc. with Mathematics as one of the group subjects or B.C.A. candidate's with Mathematics at intermediate level as a group subject or B.Tech. with Mathematics & Physics.
- **2. Physical Sciences:** Candidates with B.Sc. who have studied Physics and Chemistry or Allied Material Sciences (See Annexure-I) under Part-II group subjects or B.C.A. Candidates with Physical Sciences (Physics and Chemistry) at intermediate level as groupsubjects.
- **3. Biological Sciences:** Candidates with B.Sc./B.Sc.(Home Science) who have studied Botany and Zoology or Allied Life Sciences (See Annexure-II) under Part-II group subjects or B.C.A. candidates with Biological Sciences at intermediate level as groupsubjects.

- **4. SocialStudies:** All candidates with B.A./B.Com./B.B.M. or B.C.A. candidates with Social Sciences at intermediate level as groupsubjects.
- **5. English:** Candidates with B.A Special English or M.A.English.

IV. MEDIUM OF ENTRANCETEST

The question paper will be in English and Telugu except for English methodology. However, candidates opting to write the Entrance Test in Urdu medium will be served with Urdu paper and such candidates shall opt Kurnool as Test Centre.

V. CENTRES OF ENTRANCETEST

The Common Entrance Test will be held at the following Centres:

Anantapur, Sri Satya Sai, Chittoor, Annamayya, Tirupati, East Godavari, Kakinada, Konaseema, Guntur, Bapatla, Palnadu, Krishna, NTR, Kurnool, Nandyal, Sri Potti Sri Ramulu Nellore, Prakasam, Srikakulam, Visakhapatnam, Anakapalle, Vizianagaram, West Godavari, Eluru, YSR Kadapa.

However, Convener reserves the right to allot candidates to any other center(s) in unavoidable circumstances.

VI. QUALIFYING MARKS:

The qualifying marks in the Entrance Test for all candidates (except SC/ST) are 37 out of total marks (i.e. 25%). For the candidates belonging to SC/ST communities, there will be no qualifying marks for ranking. There will be no minimum qualifying marks for women in Physical Sciences/Mathematicsmethodologies.

VII. RESULTS:

RANKING: Candidates will be ranked in each methodology in the order of merit on the basis of marks obtained in AP Ed.CET -2022 examination. Where there is a tie in total marks, Part-C marks will be taken into account to decide relative ranking. In case of further tie, the marks obtained in Part-A will be taken into account to decide relativeranking.

In case of candidates getting equal marks in each of the parts of the test paper, they shall be bracketed for the purpose of award of rank. At the time of admission into the course, age shall be taken into consideration for relative ranking among the bracketed candidates and the older candidates shall be givenpriority.

The rank obtained in AP Ed.CET-2022 is valid for entry into B.Ed. course for the academic year 2022-2023 only.

VIII. RULES OF RESERVATION FORADMISSION:

1. Local Area-WiseReservations:

- (i) Admission to 85% of the seats in each methodology shall be reserved for the local candidates and 15% of the seats shall be left unreserved as specified in the Andhra Pradesh Educational Institutions (Regulations and Admissions) Order 1974 as amended in G.O.P.No.646 Education (W) Department, dated:10th July,1979.
- (ii) The part of the State comprising the districts of Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna, Guntur and Prakasam shall be regarded as the Andhra University-LocalArea.
- (iii) The part of the State comprising the districts of Anantapur, Kurnool, Chittoor, Kadapa and Nellore shall be regarded as the Sri Venkateswara University-LocalArea.
- (iv) All the districts of Telangana shall be regarded as the Osmania University-localarea.
- (iv) In respect of State-wide Institutions, i.e., Sri Padmavathi Mahila Visva Vidyalayam, Tirupati, Dravidian University, Kuppam admission to 85% of seats, in each methodology shall be reserved for the candidates belonging to the three local areas mentioned above and the balance of 15% of seats shall be left for the opencompetition.

2. The LocalCandidate:

- (A) A candidate for admission shall be regarded as a local candidate in relation to localarea:
- i) If he/she has studied in an Educational Institution or Educational Institutions in such local area for a period of not less than four consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared in the relevant qualifying examination.
- ii) Where, during the whole or any part of the four consecutive academic years, ending with the academic year in which he/she appeared or as the case may be first case may be first appeared for the relevant qualifying examination, he/she has not studied in Educational Institutions, if he/she resided in the local area for a period of not less than four years immediately preceding the date of commencement of the relevant qualifying examination in which he/she appeared or as the case may be firstappeared.
- (B) A candidate for admission to the course who is not regarded as local candidate under clause (A) in relation to any local area shall be as localcandidate.
- (a) If he/she has studied in educational institutions in the state for a period of not less than seven consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination, be regarded as local candidate in relationto:

- (i) Such local area where he/she has studied for the maximum period out of said period of seven years **OR**
- (i) Where the period of his/her studies in two or more local areas are equal, such local area where he/she has studied last in such equal periods **OR**
- (b) If during the whole or any part of seven consecutive academic years, ending with the academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination, he/she has not studied in the educational institutions in any local area but has resided in the State during the whole of the said period of seven years, be regarded as a local candidate in relation to:
- (i) Such local area where he/she has resided for the maximum period of the said period of seven years. **OR**
- (i) Where the periods of his/her residence in two or more local areas are equal, such local area where he/she resides last in such equalperiods.
- (C) The following categories of candidates are eligible to apply for admission to the remaining 15% of unreservedseats.
- (i) All the candidates eligible to be declared as localcandidates.
- (ii) Candidates who have resided in the State for a total period of ten years excluding periods of study outside the State.
- (iii) Candidates either of whose parents is in the employment of this State or Central Government, Public Sector Corporations, Local Bodies, Universities and similar other quasipublic institutions within the State at the time of submitting theapplication.
- (iv) Candidates who are spouses of those in the employment of the State or Central Government, Public Sector Corporations, Local Bodies, Universities and Educational Institutions recognized by the Government or University OR other competent authority and similar quasi Government institutions within the State.
- (D) If a local candidate in respect of local area is not available to fill any seat reserved or allocated in favour of a local candidate in respect of that local area, such seat shall be filled in as if it has been un-reserved.

- 2. Candidate shall with utmost precaution chose the methodology subject under PART-C of the question paper attempted based on the subjects he/she has studied at degree or post graduate level as the case may be. Convener, AP Ed.CET-2022 is not responsible for wrong selection of the methodology subject to be attempted under PART-C of the entrancetest.
- 3. Any change whatsoever, including that of caste/community status or category, shall not be permitted to be made in the filled in application once it is submitted to the Convener. No correspondence will be entertained in this regard.
- 4. The Convener is not responsible for the non-submission of application by the notified date and time for any reasonwhatsoever.
- 5. The Candidate should preserve the hall ticket to produce it at the time of test and later at the time of entry into thecourse.
- 6. Applicants should download hall tickets from website https://sche.ap.gov.in/edcetonly.
- 7. The appearance at AP Ed.CET-2022 does not entitle any candidate to be considered for entry into the courseautomatically.
- 8. The rank obtained with the benefit of relaxation of minimum qualifying marks at the AP Ed.CET-2022 by any candidate, claiming to belong to SC/ST category, will be cancelled in case the claim is found to be invalid later or at any point of time.
- 9. The selection of candidates and allotment to colleges will be on the basis of rank obtained at the Common Entrance Test and other conditions laiddown.
- 10. Candidate will not be permitted into the exam hall after the scheduled time on the date of entrancetest.
- 11. In any litigation, the party to be impleaded shall be the Convener of the AP Ed.CET-2022 only and this shall be subject to the jurisdiction of High Court of A.P.
- 12. Candidates are advised to practice the mock tests placed in the website and familiarize with the mode of attempting the onlinetest.

Teaching requires certain characteristics like ability to communicate, ability to deal with Children, ability to recognize individual differences etc., apart from analytical thinking and general intelligence. One who has these characteristics will be able to become a good teacher after training. Questions relating to these aspects will be included to test one's teaching aptitude.
