6. **Scheme of Examination:** The selection will be made entirely on the basis of merit. The selection process will comprise of Skill/Physical/Practical test and written test, wherever necessary. The selection of all Group 'C' posts will be made solely based on marks obtained by the applicants in the written test and subject to qualifying in the Skill/Physical/Practical test, as may be the case.

Note: The question papers of Written Test will be bilingual (in English & Hindi). However, the question on the portion of English Language subject will be in English only. There will be provision of negative marking (0.25 marks) in each wrong answer in written test for Techni stream.

7. Subjective Examination

(i) **General Mathematics & Statistics:** The questions will be in Mathematics, selected and would include questions of non-routine type. The test may include questions on analogies, similarities and differences, areas, calculation, certain solving methods, logarithm, fraction, ratio, etc. as well as mensuration, probability, statistics, matrices, complex numbers, differentiation, integration, etc. The test will also include questions relating to sets and the logarithmic, exponential and their relationship, arithmetical-geometrical and other analytical functions.

(ii) **General Awareness:** The questions will be of illustration standard. The questions will be designed to test the candidate's general awareness of the environment around him/her and its application in society. Questions will also be designed to test knowledge of current events and of such matters of everyday occurrence and importance in their scientific aspects as may be required of the candidate's general education. The test will also include questions relating to India and its neighboring countries, especially pertaining to Sports, History, Culture, Geography, Economy, Science, General Knowledge including Indian Constitution and Scientific Research etc. These questions will be selected, they should require a specialized knowledge of any discipline.

(iii) **English Language:** The questions will be of intermediate standard. Candidates understanding the basics of English language in vocabulary, grammar, sentence analysis, synonyms, antonyms and its correct usage. The questions shall be in Hindi.

(iv) **Mathematical Aptitude:** The paper will include questions on problems relating to Number Systems, Computation of Whole Numbers, Fractions and Decimals and relationship between Numbers, Fundamental Arithmetic Operations, Percentages, Ratio and Proportion, Averages, Interest, Profit & Loss, Discount, use of Tables and Graphs, Mensuration, Time and Distance, Time and Work etc.

4. **Important Instructions to the Applicants -**

- (A) Candidates should read the Advertisement carefully before filling up the application form. All the candidates to satisfy themselves that they are eligible to apply for the posts as per the advertisement.

- (D) **Age Limit** - Date of birth filed in by the candidate in application form and the same recorded in the meritulation Examination Certificate will be accepted for determining the age and no subsequent request will be considered or granted.
