- 3. The base level posts shall be filled up initially on contractual basis in terms of stipulations contained in G.A. Department Notification No.32010/Gen dated 12.11.2013 and G.A. Department Notification No.28621/Gen dated 27.10.2021 following the relevant recruitment rules and provisions of ORV Act. Their remuneration shall be governed by the G.A.Department Notification no.19574/Gen., dated.12.09.2017 & G.A. Department Notification No.28621/Gen dated 27.10.2021.
