4. The entire process may take 3-5 days to complete the physical verification of domicile/caste/education/ITI/Diploma certificate etc found to be suspected by the various Board of Officers during the different stages of the Assam Rifles Technical and Tradesman Recruitment Rally 2021-22.

5. No lodging & fooding will be provided by the Assam Rifles during your stay for the recruitment process.

6. The Assam Rifles will not be responsible for sustaining any injury (even cause to death) to the candidates during recruitment rally events/ transit/ stay at rally site.

7. No TA/DA is admissible.

8. If any discrepancy or false information is noticed in your documentation during the recruitment rally process and even at later stage, your candidature will be rejected/service be terminated by the Assam Rifles/Government.

9. Please note that merely qualifying in all tests does not guarantee the Final Selection into the Assam Rifles. The Final Selection will only be made on the basis of position of the candidates in Merit List in accordance with the availability of vacancies in the respective state, trade and category.

10. **Non submission of requisite documents as shown against each candidate by the above given dates will lead to cancellation of candidature of the candidate for non submission of requisite documents and NO representation in this regard will be entertained after expiry of the above given dates by Assam Rifles.**
