- 1. The DSSSB vide its advertisement no. 03/2021 dated 27/05/2021 with closing date 03/07/2021 and subsequent corrigendum dated 08/06/2021, notice dated 26/06/2021, notice to the advertisement no. 03/2021 dated 02/07/2021 had advertised 961 vacancies (EWS-25, UR-381, OBC-179, SC-188, ST-188 including PwD/OH-22 and PwD/VH-22) for the Post of TGT English-Female under post code 51/21 in Directorate of Education.
- 2. The written examination (online mode in 1st, 2nd and 3rd shift) Tier-I (Technical) for recruitment in respect of this post was conducted on 14/09/2021. The marks obtained by 10501 candidates, duly appeared in the written examination held on 14/09/2021 was uploaded on the Board's website vide notice number 1335 dated 05/01/2022 and e-dossiers were called from shortlisted candidates as per details mentioned in the said notice between 08/01/2022 to 22/01/2022
- 3. The result has been processed purely on the basis of marks obtained by the candidates in the examination held on 14/09/2021 and also claims made by the candidates in their online application forms of the post code 51/21 for the post of TGT English-Female in Directorate of Education, Govt. of NCT of Delhi. The Board has not undertaken scrutiny of documents uploaded in the e-dossiers and other terms and conditions of recruitment notified by the Board in the advertisement of the said post code at this stage, as per the Board's resolution dated 14/07/2022. The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement no. 03/2021 and relaxations as per rules in respect of educational qualifications, experience, etc. shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 51/21 as on cutoff date 10/07/2021 before issuance of offer of appointment to the post. Department while determining the eligibility of short listed candidates shall reckon the closing date given in the initial advertisement as the cutoff date for age, i.e., 03/07/2021.
- 4. On the basis of marks secured in the written Examination and considering other relaxations, if any, claimed by the candidates in their online application forms, the candidates having following roll numbers (Tier I) are hereby provisionally nominated for the post of TGT English-Female under post code 51/21 in Directorate

- 6. The selection of the above 820 candidates (UR-358, OBC-178, SC-188, ST-47, EWS-25, OH-22, VH-02) shall be further subject to thorough verification of candidature of the candidate by the User Department including the identity of the candidate.
- 7. The Selection of the above 820 candidates (UR-358, OBC-178, SC-188, ST-47, EWS-25, OH-22, VH-02) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as



prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the User Department in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

- 8. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education, Govt. of NCT of Delhi shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally nominated candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 9. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 10. The User Department shall also get the SC/ST/OBC/EWS/PH certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 and 13/09/2017 and other instructions/guidelines issued from time to time by the competent authorities.
- 11. Further, in case of EWS candidates, it may also be verified that the validity of EWS Certificate should be as per DoPT OM No. 36039/1/2019-ESTT(Res) dated 31/01/2019 and other instructions/guidelines issued from time to time by the competent authorities.

- 12. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 13. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 14. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 15. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 16. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.

(Res) dated 01/07/1998 and 43011/4/2018-Estt. (Res) dated 04/04/2018 regarding shifting of candidates from respective reserve categories to the un-reserve category.
- 26. The User Department shall operate the waiting panel up to the number of vacancies notified under each category by the DSSSB in its advertisement and not beyond it even by taking any type of relaxation from any authority as it shall rendered the excess appointment void and illegal *Ab initio*.
