PUBLIC NOTICE

RECRUITMENT TO 78 POSTS OF NAIB TEHSILDAR IN THE DEPARTMENT OF REVENUE AND REHABILITATION, GOVERNMENT OF PUNJAB.

1. It is for the information of the candidates who had appeared in the written competitive examination for recruitment to these posts held on 22/05/2022 (Sunday) that as per revised answer key, the candidates mentioned in the list attached as Annexure- A have been provisionally shortlisted. This shortlist is subject to final outcome of the CWP Nos 13095, 14366 & 12971 of 2022.
2. The candidates mentioned in Annexure- A are in the order of respective Roll numbers and not as per written competitive test merit.
3. As per the provisions of Para-10 of "General Information to the Candidates", the candidates of Annexure- A are directed to submit their online application form along with copy of all the eligibility documents by **14/09/2022** through email naibtehsildarsp@gmail.com or **by hand** in the office of PPSC, failing which their candidature for the ibid posts shall be cancelled.
4. The Candidates **MUST** submit the following Self Attested documents along with signed copy of the application form:-
 - (a) Proof of Date of Birth: Certificate of Matriculation / Higher Secondary.
 - (b) Proof of having passed Punjabi Language up to matric or its equivalent Standard
 - (c) Diploma/Degree and DMC Certificates (All Proofs.)
 - (d) Caste Reserved Category Certificate issued by the Competent Authority (If applicable).
 - (e) Latest Punjab Residence certificate (all Reserve Categories including female candidates who have applied in General Category) issued by competent authority.]
 - (f) If ESM, Certificate/documents mentioning the following
 - i) Date of Enrolment
 - ii) Date of Release/Discharge

- iii) Reasons of Release/Discharge
- g) Certificate as proof of age relaxation claim (If applicable)
- (h) Certificate as proof of fee concession (If applicable)
- (i) Proof of being Govt. Employee (If applicable)
- (j) Any other certificate, (If applicable)
- (k) Copy of Bank Challan form

5. The application forms and requisite documents of provisionally shortlisted candidates shall be scrutinized by the Commission. During the scrutiny of application forms, if any provisionally shortlisted candidate is found ineligible, then his/her candidature shall be cancelled by the Commission.

6. The number of candidates provisionally shortlisted in each category is subject to their clearing the passing criteria of 45% marks (40% for candidates belonging to Scheduled castes of Punjab and Backward Classes of Punjab). The number of such provisionally shortlisted candidates may be more than the number of posts in some categories to cater to any cancellation of candidatures arising out of the scrutiny of documents. It is reiterated that the candidates have been provisionally shortlisted subject to final outcome of the CWP Nos 13095, 14366 & 12971 of 2022.

7. While every care has been taken in preparing and uploading the list of short-listed candidates, possibility of inadvertent/technical errors cannot be ruled out. The Commission reserves the right to rectify the same later on.
