(II) RESERVATION AND RELAXATIONS:

- In making appointments in the services of the Corporation, reservations, relaxation of age limits and other concessions would be provided to Scheduled Castes, Scheduled Tribes and other category of persons as directed by Government of India from time to time.
- The prescribed qualifications, experience, age limit, etc. shall be reckoned as on 01.08.2022
- The candidates belonging to SC/ST and OBC categories are eligible for age relaxation maximum by 5 and 3 years respective
- The upper age limit in case of departmental (FCI) candidate shall be 50 years. The upper age limit is relaxed by 10 years for PwBD, 15 years for PwBD candidates belonging to SC/ST and 13 years for PwBD candidates belonging to OBC. Relaxation in age limit shall be applicable irrespective of the fact whether the post
- is reserved (for PwBD) or not, provided the post is identified for PwBD. A PwBD candidate can apply, against vacancies reflected above, for a post even if ere is no vacancy reserved for PwBD but that post has been identified as suitable for PwBD. However, such candidate will be considered for selection to such post by General standard of merit.
- The aforesaid reservation and relaxation is not applicable to OBC candidates falling ithin the creamy layer.
- Further, the reservations & relaxations will be provided to OBC Candidates as specified by the Central Government in the list prepared by the Government of India from time to time for the purpose of making provisions for reservation in
- The form of certificate to be produced by candidates belonging to Other Backward Classes should be in the format prescribed by the Government of India only. The prescribed format of the certificate to be produced should be as per Annexure-B. ected candidates will have to submit OBC-NCL Certificate issued on or after 01.04.2022, at the time of Document Verification
- EWS vacancies are tentative and subject to further directives of Government of India and outcome of any litigation. The appointment is provisional and is subject to the Income and Asset certificate being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake/false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of fake/false certificate. The Income and Asset Certificate (Annexure-C) issued by any one of the authorities mentioned in the prescribed format as given in <u>Annexure-C</u> shall only be accepted as proof of candidate's claim as belonging to EWS.

If there are no posts reserved for reserved category candidates belonging to SC/ST/OBC/EWS category; these candidates may apply against unreserved posts; provided they meet all the criteria prescribed for unreserved candidates.
