### PUBLIC NOTICE

#### **RECRUITMENT TO 418 POSTS OF VETERINARY OFFICER IN THE DEPARTMENT OF ANIMAL HUSBANDRY, FISHERIES AND DAIRY DEVELOPMENT, GOVERNMENT OF PUNJAB.**

1. It is for the information of the candidates who had appeared in the written competitive examination for recruitment to these posts held on 21/08/2022 (Sunday), that as per revised answer key, the candidates mentioned in the list attached as Annexure- A have been provisionally shortlisted for Interview.
2. The candidates mentioned in Annexure- A are in the order of respective roll numbers and not as per written competitive exam merit to keep the written exam score concealed from the interview panel.
3. As per the provisions of paragraph-8.6 of "Revised General Information to the Candidates", the candidates of Annexure- A are directed to submit their online application form along with copy of all the eligibility documents by **22/09/2022** through email(pdf format in single file) at [vo2021.ppsc@gmail.com](mailto:vo2021.ppsc@gmail.com) or **by hand** in the office of PPSC, failing which their candidature for the ibid posts may be cancelled.
4. The Candidates **MUST** submit the following Self Attested documents along with signed copy of the application form:-
  - (a) Proof of Date of Birth: Certificate of Matriculation / Higher Secondary.
  - (b) Proof of having passed Punjabi Language up to matric or its equivalent Standard.
  - (c) Diploma/Degree and DMC Certificates, proof of registration with the Punjab Veterinary Council etc. as mentioned in Essential Qualification of General Information.
  - (d) Caste Reserved Category Certificate issued by the Competent Authority (If applicable).
  - e) Latest Punjab Residence certificate (all Reserve Categories including female candidates who have applied in General Category) issued by competent authority.

- (f) If ESM/LDESM(in original), Certificate/documents mentioning the following
- i) Date of Enrolment
  - ii) Date of Release/Discharge
  - iii) Reasons of Release/Discharge
- g) Certificate as proof of age relaxation claim (If applicable).
- (h) Certificate as proof of fee concession (If applicable).
- (i) Proof of being Govt. Employee (If applicable).
- (j) Any other certificate, (If applicable).
- (k) Copy of Bank Challan form.

5. The application forms and requisite documents of provisionally shortlisted candidates for interview shall be scrutinized by the Commission. During the scrutiny of application forms, if any provisionally shortlisted candidate is found ineligible, then his/her candidature shall be cancelled by the Commission.

6. The number of candidates provisionally shortlisted in each category is subject to their clearing the passing criteria of 45% marks (40% for candidates belonging to Scheduled castes of Punjab and Backward Classes of Punjab). The number of such provisionally shortlisted candidates may be more than the number of posts in some categories to cater to any cancellation of candidatures arising out of the scrutiny of documents.

7. While every care has been taken in preparing and uploading the list of short-listed candidates for interview, possibility of inadvertent/technical errors cannot be ruled out. The Commission reserves the right to rectify the same later on.
