3. The candidates are required to attend on the scheduled date along with following Original Certificates/Documents and two sets of Photostat copies.

- i. S.S.C/SSLC/10th Class Pass Certificate.
- ii. Diploma Certificate in Electrical Engineering or Electrical & Electronics Engineering.
- iii. Permanent Community Certificate issued by the competent authority in Govt. of Telangana in respect of SC/ST & BC candidates clearly indicating the Sub-Caste and group.
- iv. Latest Non Creamy Layer Certificate in Form-VIIB in case of BCs by the competent authority in Govt. of Telangana.

- v. Latest EWS Certificate in original obtained from the competent authority in Govt. of Telangana in respect of candidates claiming to be belonging to Economically Weaker Sections (EWS).
- vi. School Bonafide Certificates or School Study Certificates (as prescribed in the Notification) from Class I to Class VII issued by the Principal/Head Master.
- vii. Residence Certificate if not studied up to Class-VII in regular mode (as prescribed in the Notification) obtained from Competent authority of Telangana Government.
- viii. Original Hall Ticket of Written Examination.
 - ix. In case of PH candidates with Visually Handicapped/ Hearing Disability/ Orthopedically Handicapped/Autism, certificates obtained from Competent Medical Authority in SADAREM Format relevant to them.
 - x. No Objection Certificate from the Employer (If employed anywhere)
 - xi. Any other Certificates specified in the Notification.
 - xii. Two Nos. Latest Pass port size photos.

4. On verification of Original Certificates, if it is found that the same are not in order with reference to particulars furnished by him/her in the Application Form / Check List / Certificates or if furnished any false information, his/her candidature for the post of Sub-Engineer/Elecl. will be cancelled at any stage of selection process.

5. The candidate is required to attend on his own costs and not entitled for any reimbursement of Travelling/Dearness charges. Request for change of scheduled dates will not be entertained and if not attended for Certificate Verification on the above said date, the candidature will be disqualified and he/she will not have any right to claim for appointment for the post of Sub-Engineer/Elecl. against the said notification.

6. Mere attending for Verification of Original Certificates doesn't confer any right for selection / appointment. Failure to produce any of the original Certificate/document which is required as per Notification on the given date will lead to disqualification. No representations/queries will be entertained from unsuccessful candidates.

7. The sole discretion lies with TSSPDCL to alter or modify any terms and conditions or instructions or schedule, as warranted by any unforeseen circumstances arising during the course of this process, or as deemed necessary by TSSPDCL at any stage.
