2. Essential Educational Qualifications and Eligibility:

2.1 Essential Educational Qualification:

2.1.1 Engineering Apprentices:

- a) A degree in engineering or technology granted by a statutory University; or
- b) A degree in engineering or technology granted by an institution empowered to grant such degree by an act of Parliament; or
- c) Graduate examination of professional bodies recognized by the Central Government as equivalent to a degree; or
- d) A sandwich course student who is undergoing training in order that he may hold a degree in engineering or technology as mentioned at (a) and (b) above.

2.1.2 Diploma Technician Apprentices:

a) A Diploma in engineering or technology granted by a State Council Board of Technical Education established by a State Government Or

b) A Diploma in engineering or technology granted by a University Or

c) A Diploma in engineering or technology granted by an Institute recognized by

State Government or Central Government as equivalent to (a) and (b) above Or

d) A sandwich course student who is undergoing training in order that he may hold a Diploma mentioned in (a), (b) and (c) above.

2.2 Only Fresh pass out students are eligible for apprenticeship training only up to 3 years after passing their degree/diploma. Engineering Graduates or Diploma Holders who had training or job experience for a period of one year or moreafter attaining the essential qualifications shall **NOT** be eligible for being engaged as an apprentice under the Act.

2.3 If the gap between the date of declaration of result and date of commencement of training is more than one year, an affidavit on stamp paper duly signed by Magistrate/Notary has to be submitted by the apprentices. Matter of the affidavit will remain same as of declaration in the format given in Para 7 below.

3. SELECTION PROCEDURE:

3.1 Selection of Candidates will be made through <u>Walk-In Interview.</u>For this the list of candidates called for interview will be published in the website of Ammunition FactoryKhadki, Pune i.e. <u>http://ddpdoo.gov.in/units/AFK</u>

3.2 No formal communication will be made to the candidates forattending Walk-In Interview. The candidates are required to visit the web-site from time to time for publication with respect to Calendar Events, for Latest Updates or change in Calendar Events.

3.3 Candidates meeting the eligibility criteria should apply by post in the prescribed format with declaration that they will submit all desired documents during document verification at the time of Walk-In Interview. In case of failure to submit any of the desired documents, the Candidate will not be permitted for Walk-In Interview and his /her candidature will be rejected.

3.4 Deferment of date of Walk-In-Interview will not be permitted / considered.

3.5 List of documents along with original to be submitted during document verification(**if invited for**) shall be as follows –

- 3.5.1 Copy of Aadhaar Card as ID Proof.
- 3.5.2 Copy of SSC Mark Sheet & SSC Certificate.
- 3.5.3 Copy of Mark Sheet & Certificate of Final Year Engg. Graduate/Diploma.
- 3.5.4 Copy of Caste & Validity Certificate, Non Creamy Layer Certificate for OBC candidate, PH Certificate for Physically Handicapped candidates as applicable.
- 3.5.5 Declaration Affidavit as per format on Plain paper / Declaration Affidavit as per format on stamp paper (Non Judicial) whichever applicable.
- 3.5.6 05 Copies of Attestation form duly filled in (form to be downloaded from web site http://www.afk.gov.in) for verification of character antecedents.
- 3.5.7 05 copies of Passport size coloured photographs in red background.
- **3.6** List of selected candidates will be called for medical examination before joining after receipt of clear PVRs.
- **3.7** The selected candidates will be issued joining letter for Apprenticeship Training after verification of Character antecedents and fitness in medical examination.
- **4. Qualifying Age:** Not less than 14 years of age as on last date of submission of application i.e. 21 days from date of publication of advertisement in Newspaper.

5. Important Dates / Calendar Events:

- **5.1** Last date for receipt of Application at Ammunition Factory Khadki: 21 days from date of advertisement.
- **5.2** Do visit AFK website for further updates.

6. General Information:

- 6.1 It is not obligatory on the part of the employer to give employment to the candidates on completion of their training.
- 6.2 Candidates should note that any addendum/corrigendum in respect of change in engagement of Apprentices will be published in our website only and no separate notice will be issued in this regard.
- 6.3 Date of Document Verification, Interview and Medical Examination will be notified in our website <u>http://ddpdoo.gov.in/units/AFK</u> for which separate call letter will not be issued.
- 6.4 Request for change in date of Document Verification, Interview and Medical Examination will not be entertained.
- 6.5 a) Application (as per Annexure A) to be forwarded in sealed envelope with title as "APPLICATION FOR THE POST OF GRADUATE /DIPLOMA APPRENTICE – (Group Code)" indicating Group code of the designated Trade / Discipline on top of the envelope.

- 6.6 Not filling of google form / Incomplete applications / applications received after the last date will not be entertained.
- 6.7 It is mandatory for the candidates to register themselves on NATS portal <u>www.mhrdnats.gov.in</u> and the same will be verified on the day of document verification (**if invited for**).
- 6.8 No accommodation will be provided for selected candidates by AFK during training.

7. DECLARATION / AFFIDAVIT:

- 7.1 The declaration / affidavit as per **Annexure B**isto be filled up by the applicants.
- 7.2 The declaration has to be signed by the candidate, if the gap between date of passing and date of joining the apprenticeship training is less than one year.
- 7.3 If the gap is more than one year, the affidavit has to be furnished on stamp paper in the above format, duly signed by Magistrate/Notary.
- 7.4 Copy of the declaration / Affidavit to be submitted along with application form (Annexure A)& original to be submitted during Document Verification.

- 8.1 Engineering Graduate Apprentice @ Rs. 9,000/- per month consolidated
- 8.2 Diploma (Technician) Apprentices @ Rs. 8,000/- per month consolidated

9. Reservation:

As per the provisions contained in the Apprentice Rule 2015. Copy of Certificate from competent issuing authority is required to be submitted for obtaining Reservation. **OBC candidates are required to submit Non-Creamy-Layer-Certificate (NCLC) valid as on closing date of receipt of application**. Candidates not having valid certificate in respect of Reservation will be considered as unreserved candidate.
