# **3. OTHER ELIGIBILITY CONDITIONS:**

- a. Indian Nationals belonging to the state of Odisha are only eligible to apply.
- b. Age: Candidate should not be less than eighteen years of age as on 30.09.2022.
- c. Educational Qualification: As per Table-B.
- d. The prescribed qualification shall be from a recognized Board / Council / University / Institute as a regular full-time course.
- e. Candidates shall have Minimum Physical Standard as prescribed in Clause 4 of the Apprenticeship Rules 1992 and amended thereof.
- f. Candidates who have completed Apprenticeship training as per Apprentices Act 1961 or job experience for a period of one year or more shall not be eligible to apply.
- g. The candidate who are appearing for requisite essential qualifying examination will not be eligible to apply.



- h. The candidate should have the passing certificate / final year mark sheet of the required qualification as on 30.09.2022.
- i. The gap between the date of joining in Apprenticeship Training and passing date of essential qualifying examination for Graduate (Degree) Engineering Apprentices & Diploma (Technician) Engineering Apprentices **should not be more than 3 years** and passed during Academic Year **2019-20**, **2020-2021** & **2021-2022**.

# 4. PERIOD OF APPRENTICESHIP TRAINING:

- The period of apprenticeship training in the case of Graduate (Degree) Engineering Apprentices, Diploma (Technician) Engineering Apprentices shall be one year i.e., 12 Months.
- The training period commencing from the online contract date of Apprenticeship Training and will be for one year and the Apprentices shall be paid stipend from start of online contract date subject to satisfactory performance.

**N.B:** It shall not be obligatory in the part of OPTCL to offer employment to any apprentice who has completed his / her apprenticeship, nor can an apprentice claim right for employment on the ground of completion of Apprenticeship Training.

#### 5. LOCATION OF APPRENTICESHIP TRAINING:

- a. Apprenticeship Training will be provided at different Units and offices of OPTCL spread across all over Odisha.
- b. No accommodation shall be provided to the engaged apprentices by OPTCL at the training locations.
- c. Apprentices shall have to abide by safety rules strictly at their respective places of engagement.
- d. All COVID-19 related guidelines issued by Central / State / Local authorities shall be strictly adhered to by engaged Apprentices at the location of Apprenticeship Training.

#### 6. **RESERVATION**:

- a. Reservation will be provided as per the provisions of the Apprentice Act, 1961 (amended) and Apprenticeship Rules 1992 (amended).
- b. Applicants belonging to SC/ST/SEBC shall produce their valid caste certificates in the prescribed format issued by the Competent Authority. Certificates should have validity on the date of Document Verification.
- c. When the prescribed number of persons belonging to either to the Scheduled Castes or to the Scheduled Tribes are not available, the training places so reserved for them shall be filled by persons belonging to Scheduled Tribes or as the case may be, to the Scheduled Caste and if the prescribed training places cannot be filled even in the above given manner, then the training places so lying unfilled may be filled by persons not belonging to the Scheduled Tribes.



d. If the prescribed training places cannot be filled from SEBC candidates, then the training places so lying unfilled shall be filled up by Candidates not belonging to the SEBC category.

# 7. MODE OF SELECTION:

- a. In the event of number of applications being large, OPTCL will adopt short listing criteria to restrict the number of candidates to be called for interview to a reasonable number by drawing a merit list in the order of the percentage secured by the applicant in the prescribed essential educational qualification. Wherever CGPA/CPI or Grades in qualifying examination is awarded, equivalent percentage (%) of marks should be indicated in the application form as per norms adopted by concerned Board / Council / University / Institute. The candidate shall be required to submit a certificate to this effect from the Board / Council / University / Institute at the time of reporting, in case of final selection.
- b. The candidates from the merit list will be called for Documents Verification & Personal Interview, if found suitable then a separate final merit list will be prepared on the basis of Interview marks, Career Marking and Location Preference. Only one (1) week time period will be given to the provisionally selected apprenticeship trainee to accept online generated contract and subsequent joining at place of engagement. If the trainee does not join within the given time his/her candidature will be summarily cancelled.
- c. The wait list of candidates will be prepared and operated as and when required.
- d. In case of candidates securing equal marks in the merit list (even after considering the decimal points) the candidate securing more marks in the preceding educational qualification will be placed at higher position in the merit list.

# 8. PROCEDURE FOR SUBMISSION OF APPLICATION:

Interested candidates who fulfils the eligibility criteria may submit their application as below:

- a. Candidates should first register themselves (as a candidate) on the website <u>https://portal.mhrdnats.gov.in</u> (for Apprentices belonging to Graduate (Degree) Engineering / Diploma (Technician) Engineering Apprentices of Table A)

- a. Incomplete / erroneous applications will be rejected. No further communication in this regard will be entertained. Educational, Personal, Bank account details and Aadhaar Card details must be entered duly in profile of respective apprenticeship portal login by the candidate. Any discrepancy or lacunae found in this regard at any stage will render the candidate ineligible for the Apprenticeship training.
- b. Canvasing / Pressuring through any source will disqualify the candidature and their name will be removed from our official record without prior intimation and this organisation will not responsible for such cases.
- c. At any stage of the selection process of Apprentices, if it is found that the candidate has furnished false or incorrect information, then the candidature / engagement of the candidate is liable to be cancelled.
- d. The decision of Management of OPTCL will be final and binding on all candidates on all matters relating to eligibility, acceptance or rejection of the application, mode of selection, and cancellation of the selection process either in part or full etc. No correspondence will be entertained in this regard.
