## **Result Notice**

- Food Corporation of India, Punjab Region vide advertisement no.01/2021/PUNJAB had advertised 860 vacancies for the post of Watchman in Punjab Region. Further, Written Test for the said post was conducted on 09-10-2022 (Sunday).
- 2. Whereas, based on the performance in written examination candidates were provisionally shortlisted to appear in PET test in the ratio of 1:3 including all the candidates who have scored marks equal to the cut off marks in each category as bracketed candidates.
- 3. Whereas, the PET for the shortlisted candidates was successfully conducted from 19/12/2022 to 22/12/2022.
- 4. Now, based on the performance of candidates in the Written Test and PET the result of the advertisement no. 01/2021/PUNJAB is hereby declared and will be displayed in the candidate's dashboard on the designated portal i.e. <a href="https://fci-punjab-watch-ward.in">https://fci-punjab-watch-ward.in</a>.
- 5. In case of equal marks, the merit was assigned taking into consideration the date of birth (i.e. preference is given to the elder).
- 6. As mentioned in Note 7 of advertisement, a candidate has to score minimum qualifying marks equal to 40 % of total 120 marks. However, the minimum qualifying marks for the Erstwhile Contractual Security Guards were 30 % of total 120 marks. Hence, all those candidates who failed to obtain the minimum qualifying marks in their respective category have been disqualified in the first place.

- 7. Further, the candidates have been shortlisted subject to correctness of information furnished by each candidate in the online application. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates does not entitle them any right over the post.
- 8. All these shortlisted candidates will be required to appear in person along with all original documents/certificates in prescribed formats regarding their claim of essential qualification, age, category, Ex-SM status, and disability certificates at the FCI, RO, Punjab on a schedule that will be informed in due course of time. Further, applicants under Erstwhile Contractual Security Guards category will be required to produce original i-card, EPF No., Salary slip and Contractual orders pertaining to the period they were engaged as contractual security guards at the time of document verification.
- 9. Further, all those applicants who are currently the employees of Centre/State Govt./PSU and departmental candidates of FCI will have to produce in original a 'No Objection Certificate' issued by their current employer issued on or before the closing date of application.
- 10. Further, the nomination of the candidates for declaration is merely provisional and subject to candidate producing documents in support of claim of age, education, disability, category otherwise, his/her candidature will be summarily rejected without giving any further opportunity. Further, at any stage, if the candidate is found to be guilty of impersonation or any other malpractices/use of any prohibited means to qualify the written examination or PET he/she will be debarred from all future recruitments of the corporation and legal action as deemed appropriate will be taken against such candidates by the Corporation.

- 12. The result will be subject to outcome of pending court cases, if any, related to the above vacancy.
