NOTICE

Subject:- Declaration of Marks of Skill Test (Driving) held w.e.f. 31.05.2022 to 01.08.2022 for the Post of Fire Operator, Post Code-18/19 in Delhi Fire Service- regarding.

The DSSSB vide its advertisement No. 04/19 dated 24.09.2019 had advertised total 706 (EWS-21, UR-190, OBC-115, SC-309, ST-71) vacancies for the post of Fire Operator in Delhi Fire Service, Post Code-18/19 with closing date as 06/11/2019.

Physical Endurance Test (PET) was held w.e.f. 11.01.2020 to 22.02.2020. Online Written Examination was held on 20.04.2021 & 22.04.2021. Skill Test (Driving) which was held w.e.f. 31.05.2022 to 01.08.2022.

- 2. The marks of Physical Endurance Test were declared vide notice dated 05.04.2021and marks of written test were declared vide notice dated 09.07.2021. Now, on the basis of marks scored by the candidates who duly appeared in Skill Test (Driving) held w.e.f. 31.05.2022 to 01.08.2022 have been uploaded on the Board's website. The driving skill test was conducted in 02 parts, namely Theory for 20 marks & Practical for 80 marks. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in
- 3. Further, taking into consideration the RRs, selection criteria and as per decision of Delhi Fire Service department vide letter dated 29.11.2022 of Chief Fire Officer, the final result has been prepared consisting 100 marks for PET, 100 marks for Written Test and 100 marks for Driving Skill Test. Each module i.e. Physical Endurance Test, Written Test and Driving Skill Test has been given equivalent weightage while preparing the merit list. The written test which was taken for 200 marks have been converted/scaled down proportionately to 100 marks for equivalent weightage with other modules.

Hence, merit / shortlisting has been prepared based on total marks obtained out of 300 (i.e. 100 marks each for Physical Endurance Test, Written Test & Driving Skill Test)

4. Accordingly, based on the performance in the Physical Endurance Test, Written test & Driving Skill test, a total of 1486 candidates have been found qualified and out of which 1099 shortlisted candidates on merit have been provisionally allowed to upload edossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidate in his online application forms.

5. Accordingly, the category wise cutoff marks for uploading of e-dossier in OARS module is given as under:-

- 6. The shortlisted candidates for the above mentioned post code are hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards/Driving license etc., as applicable in the E-dossier module in OARS link in his individual account in OARS module. Short listing is being made on the basis of marks obtained out of 300 marks i.e. 100 marks each for Physical Endurance Test, written examination & Driving Test.
- 7. Kindly note that the e-dossier link will be activated to only those candidates who are in the consideration zone of selection.
- 8. The candidate who has been shortlisted for falling in the consideration zone of selection MUST upload his/her all requisite / applicable documents in the said link in stipulated time.
- 9. The e-dossier link shall be activated for a period of 15 days w.e.f. 05.01.2023 to 19.01.2023. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e 06.11.2019. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number & e-mail id. as an additional facility. If, the candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.
- 10. Mere asking the candidate for uploading documents in the e-dossier module does not confer him any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
- 11. While every care has been taken in preparing the list of qualified candidates, DSSSB reserve the right to rectify errors and omissions, if any detected at any stage or arising due to court case.
