**NOTE:**

- Out of 131 vacancies notified, seven (7) posts have been reserved as per the interim orders of the Hon'ble High Court in W.P.No.24307 of 2021 and W.P.(MD).No.4882 of 2023.
- The candidates have been provisionally selected based on the marks scored by them in the Computer Based Test held on 20.10.2022, duly following the communal roster and rules of reservation of Government of Tamil Nadu. In

case where the marks obtained by two or more candidates are equal, the rank among them is decided based on the date of birth.

- c) Any claims preferred by the candidates should reach within 10 days from the date of issue of this provisional selection list, and appeals received after 10 days will not be entertained.
- d) The differently abled candidates shall fulfill the norms as per G.O. (Ms).No.20, Welfare of Differently Abled Persons (DAP.3.2) Department, dated 20.06.2018.
- e) The reservation to the posts has been made as per section 27 of Tamil Nadu Government Servants (Conditions of service) Act, 2016.
- f) The selection is purely provisional. The provisional selection and consequent appointment are subject to the outcome of the result of the W.P.Nos.22349, 22351 to 22354, 22358 and 22359 of 2021, W.P.No.23184 of 2021, W.P.No.26930 of 2022 and W.P.No.30264 of 2022, W.P.Nos.5837, 5842, 5846 and 5847 of 2023 relating to this recruitment and any other writ petitions / writ appeals pending on the files of the Hon'ble High Court of Madras / Madurai Bench of the Madras High Court.
- g) **The Appointment and posting order will be issued by the Commissioner, Food Safety and Drug Administration Department, Chennai separately.**
