HIGH COURT OF ANDHRA PRADESH: AMARAVATI

The High Court of Andhra Pradesh had issued Notification Nos. 1/2022 to 10/2022, dated 21.10.2022 to fill up both Technical posts viz. Stenographer Grade-III, Typist, Copyist and Driver (Light Vehicle) and Non technical posts viz. Junior Assistant, Field Assistant, Examiner, Record Assistant, Process Server an Office Subordinate. Online applications were invited to fill up all the notified posts. Computer Based Test was conducted from 22.12.2022 to 02.01.2023. The key and response sheets were published on the Official Website of High Court of Andhra Pradesh on 04.01.2023. After considering the objections of the candidates and after implementing normalization, the results are about to be published.

However, on account of establishment of new Courts and giving Compassionate appointments to the heirs of the deceased employees in various districts, there is increase and decrease of certain category of posts in the districts of Anantapuram, East Godavari, Guntur, Kadapa, Krishna, Kurnool, Nellore, Prakasam, Visakhapatnam.

The High Court of Andhra Pradesh in all the Notification viz., Nos. 1 to 10 dated 21.10.2022 under the caption of '**Note Point. 1'** categorically stated that the High Court of Andhra Pradesh reserves the right to increase or decrease the number of vacancies or cancel the notification at any stage without assigning any reason whatsoever. It was further mentioned that no right will accrue to the candidates by virtue of the Notification.

In consonance with the above captioned 'Note Point 1' and on account of establishment of new Courts so also Compassionate appointments, there is increase and decrease of posts as mentioned in the below tables.
