- 4. Selection is based on merit list prepared with 70% weightage in 10<sup>th</sup>/SSLC marks and 30% weightage in CTS (ITI examination).
- 5. Ex-ITI candidates shall register in the portal www.apprenticeshipindia.org/candidate-registration and registration number must be indicated in the application.
- 6. Incomplete applications will not be considered for selection under any circumstances.
- 7. Candidates who have undergone Apprenticeship Training or undergoing Apprenticeship Training or having work experience of one year or more are not eligible.
