PRELIMINARY OBJECTIVE TYPE/SCREENING TEST

The Preliminary objective type/Screening test shall consist of two papers viz Paper-A & Paper-B of Objective type (Multiple Choice Question). Each paper carries a maximum of 225 marks. The time allowed for each paper shall be two hours. The marks obtained in the Preliminary objective type/Screening test shall count only for short listing of the candidates for appearing in the Jammu and Kashmir Civil Service (Judicial) Competitive (Main) Examination.
