Whereas, the Provisional official answer key(s) were notified and uploaded on the official website of the Commission for information of the candidates on 10.11.2023 [Accountancy and Taxation Banking Corporation, Bioinformatics, Mathematics, Physics, Nutrition, Tour & Travel, Cost Accounting, Education, Horticulture Technology, Music/Music (Instrument/Vocal) and Handloom & Handicrafts], inter-alia notifying that, if any candidate feels that the keys to any of the questions is wrong/incorrect, he/she may prefer a representation/ objection on the prescribed proforma to the Controller of Examinations within a period of two days from the date of its notification, i.e. from 13.11.2023 from 14.11.2023 (5:00 p.m.) along with documentary proof /evidence and the fee of Rs.500/- per question; and
3. Whereas, in response to the said notification, number of objections/ representations were received by the J&K Public Service Commission against Provisional Answer Key(s) issued; and
4. Whereas, all the objections/representations were referred to the Committee(s) of Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Independent Expert opinion; and

5. Whereas, the independent team of Experts have recommended changes in the Provisional Official Keys in respect of the said papers;

Now, therefore, in view of the above and on the basis of opinion of the independent teams of Experts, it is hereby notified that:-

- a) The changes recommended by the Committee(s) of Experts are hereby adopted and the Final Official Answer Key(s) are annexed to this notification as Annexure A, B, C, D, E, F, G, H, I, J and K in respect of Assistant Professor(s) in Higher Education Department in the disciplines of **Accountancy and Taxation Banking Corporation, Bioinformatics, Mathematics, Physics, Nutrition, Tour & Travel, Cost Accounting, Education, Horticulture Technology, Music/Music (Instrument/Vocal) and Handloom & Handicrafts respectively**.
