- (a) The candidates belonging to PWD (**whose permanent disability is 40% or more**) / Sports Person categories when selected as per reservation provided for them, shall be adjusted against the categories to which they belong.
- (b) Exchange of reservation between Scheduled Caste and Scheduled Tribe will not be considered.
- (c) In case of non-availability of eligible/ suitable women candidate(s) belonging to the respective category, the unfilled vacancies of that category shall be filled up by eligible/suitable male candidate(s) of the same category.
- (d) The number of vacancies to be filled up on the basis of this recruitment is subject to change by Government without notice, depending upon the exigencies of public service at the discretion of the State Government.

### 3. AGE :

A candidate must not be above 45 (forty-five) years of age and under 21 (twenty-one) years of age on the last date of receiving / submission of online application 16.04.2024, i.e. he or she must have been born not earlier than **17.04.1979** and not later than **16.04.2003**

The upper age limit prescribed above is relaxable by **05 (five) years** for candidates belonging to SC/ST/ SEBC/Women and by **10 (ten) years** for Persons with Disabilities whose permanent disability is 40% and more.

Persons with Disabilities belonging to SC/ST/SEBC categories are eligible for cumulative age relaxation of 15 (fifteen) years i.e. 10 years under PWD category and 05 years under SC/ST/SEBC category.

SAVE AS PROVIDED ABOVE, THE AGE LIMITS PRESCRIBED CAN IN NO CASE BE RELAXED.

Date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council will only be accepted by the Commission.

### 4. EDUCATIONAL QUALIFICATION:

A candidate must:-

- (A) Possess a Master's Degree, with at least 55% of marks or its equivalent grade, in the concerned/ relevant/ allied subject from an Indian University or an equivalent degree from a Foreign University.

Provided that for the candidates belonging to **Scheduled Caste (SC), Scheduled Tribe (ST), Socially and Educational Backward Classes (SEBC) & Persons with Disabilities (PWD) categories**, the requirement of securing at least 55% marks shall be reduced to 50% marks or its equivalent grade.

- (B) have cleared National Eligibility Test (NET) meant for appointment of Assistant Professor (Stage-I) or must have acquired a Ph.D. Degree in



the concerned/ relevant/ allied subject from an Indian University or a Foreign University.

(C) The relevant/allied subject are enclosed to this advertisement as Annexure-'B'.

#### **5. EXAMINATION FEES:**

The candidates are exempted for payment of examination fees as per G.A. Deptt. Letter No.9897/Gen., dated 11.04.2022.

#### **6. CONDUCT OF EXAMINATION / METHOD OF SELECTION:**

- A. Selection for direct recruitment to the rank of Assistant Professor (Stage-I) shall be made by the Commission on the basis of merit to be judged by performance in interview of eligible shortlisted candidates.
- B. The Academic score as specified in **Appendix-II (Table 3B)** for colleges as per UGC regulation, 2018 shall be considered for shortlisting of candidates for interview which is appended as **Annexure - A** to this advertisement.
- C. Based on the data provided by the candidates in their online application form, candidates shall be shortlisted for document verification in the ratio of 1:6 for vacancies more than 02 (two) and for vacancies up to 2 (two), the number of candidates to be called for document verification shall be 12 (twelve).
- D. The Commission have decided that 03 (three) times the number of vacancies shall be shortlisted for interview when the number of vacancies is more than 02 (two). In cases, where there are only one or two vacancies, 10 (ten) candidates shall be shortlisted for interview.
- E. On the basis of the result of interview, the Commission shall prepare a subject-wise merit list of successful candidates, arranged in order of merit, equal to the number of posts to be filled up, and furnish the same to the Government.



## 7. OTHER ELIGIBILITY CONDITIONS:

- (i) The candidate must be a citizen of India;
- (ii) The candidate must be able to read, write and speak in Odia and should have passed Upper Primary Examination, or its equivalent, with Odia as a subject.
- (iii) A candidate, who has more than one spouse living, will not be eligible for appointment unless the State Government has exempted his/her case from operation of this limitation for any good and sufficient reasons;
- (iv) If a candidate has at any time, been debarred for a certain period/chance(s) by the Odisha Public Service Commission or other State Public Service Commission or U.P.S.C. from appearing at any examination/interview, he/she will not be eligible for such recruitment for that specified period/chance(s);
- (v) Government servants, whether temporary or permanent, are eligible to apply provided that they possess the requisite qualification and are within the prescribed age-limit as provided under Para-3 & 4 of the Advertisement. They must inform their respective Heads of Offices in writing regarding submission of their applications for this recruitment and submit **"No Objection Certificate" during document verification;**
- (vi) Only those candidates, who possess the requisite qualification and fulfil other eligibility conditions by the closing date of submission of online applications will be considered eligible.
- (vii) Every candidate selected for appointment shall be examined by the Medical Board. A candidate, who fails to satisfy the Medical Board, shall not be appointed;
- (viii) A candidate who claims change in his/her name after having passed the High School Certificate Examination or equivalent examination, is required to furnish copy of publication of the changed name in local Gazette in support of his/her change of name.

**8. OTHER IMPORTANT POINTS:**

- (i) **Online applications submitted to OPSC if found to be incomplete/incorrect in any respect are liable to rejection without entertaining any correspondence with the applicants on that score;**
- (ii) Admission to Viva Voce Test will be **provisional**. If on verification at any stage before or after the Viva Voce, it is found that a candidate does not fulfil all the eligibility conditions, his/her candidature will be liable to rejection. Decision of the Commission in regard to eligibility or otherwise of candidate shall be final;
- (iii) This advertisement should not be construed as binding on the Government to make appointment.
- (iv) Concessions meant for S.E.B.C & S.C./ S.T. categories by Birth are admissible to the Socially Educationally Backward Classes, Scheduled Castes & Scheduled Tribes of Odisha only;
- (v) **Community (SC/ST/SEBC) once mentioned by the candidates under the appropriate box of the online application form, will be treated as final and the same shall not be changed subsequently under any circumstances.**
- (vi) Any misrepresentation or suppression of information by the candidate in the online application, will **result in cancellation of his/her candidature or penalty, as decided by the Commission, be imposed on the candidate;**

Candidates are required to **upload the scanned copy of the original certificates, mark-sheets and other documents** while filling the online

If a candidate fails to furnish any of the original documents/ certificates at the time of document verification, he/she shall not be allowed to appear at the interview & candidature shall be rejected.

**NOTE-1:**

- (xiii) **No objection certificate** from their competent authorities in case of Government Servants.
- (xiv) **Any proof of identity.**

**NOTE 2:**

- (i) **Candidates claiming to be belonging to S.E.B.C /S.C./S.T. categories by birth are required to submit copy of the relevant Caste Certificate as mentioned in their online application form & issued by the competent authority in the prescribed form. Candidates of SEBC category (other than Creamy Layer) must submit copy of Caste Certificate issued by the competent authority within the last three years by the closing date for submission of online application form in the prescribed format.**

- (e) Not coming within the age limit of candidate as mentioned in Para - 3 of Advertisement (Overage relaxation shall not be allowed to P.W.D. candidates with less than 40% permanent disability).

- (f) **Not having requisite qualification as provided under Para - 4 of Advertisement.**
- (g) **Not furnishing copies of certificates/documents as provided under Para - 9 of the Advertisement..**

(d) The online application form is automated and system driven and will guide the candidate seamlessly in filling the application. The requisite options shall be enabled and information shall be asked as per data furnished by the candidate. Before filling up the information, ensure that accurate information is fed, for edit option is limited & on confirmation there is no scope for further edit even if wrongful entry has been made while filling up application.

(e) Candidates are requested to upload the scanned image of latest passport size photograph along with scanned image of his/her full signature and scanned image of Left-hand Thumb Impression (LTI) in the online application form. Uploaded photograph, Specimen (full) signature and LTI must be clearly identifiable / visible, otherwise the application of the candidate is
