**NOTIFICATION**

**Subject: Final Selection List-cum-Allocation of cadres & Departments notified for the remaining Class-IV posts (Hearing Category/PwBD candidates), advertised vide Notification No. 01 of 2020 dated 26.06.2020.- Cancellation of withheld recommendation thereof.**

Whereas, the J&K Services Selection Board, vide Notification No. JKSSB/55/2022-05(E-7048574) dated 20.07.2023, notified the Final Selection List of candidates for 80 posts of Class-IV (now MTS), earmarked under Horizontal Reservation for the Sub-category of Deaf & Hard of Hearing among the Persons with Disabilities (PwDs) and advertised vide Notification No. 01 of 2020 dated 26.06.2020; and

Whereas, among others, the recommendation of the candidates, as figuring in **Annexure-A**, was kept withheld for the reasons as indicated against each; and

Whereas, these cases were placed in the Board in its 247<sup>th</sup> meeting, which decided that these withheld recommendations shall be cancelled after affording an opportunity of being heard to the concerned candidates by way of a Notice; and

Whereas, the JKSSB vide Notice No. JKSSB/55/2022-05 (7048574) dated 10.01.2024 and dated 12.01.2024, these candidates were given a final opportunity to submit the necessary documents in support of their withheld candidature before the Board within stipulated time period; and

Whereas, these candidates, despite the lapse of considerable time, have failed to submit any document(s) and the matter was placed again before the Board, which, in its 260<sup>th</sup> meeting, decided to cancel the withheld recommendations of all such candidates; and

Whereas, a Final opportunity by way of Notice bearing No. JKSSB/55/2022-05 (7048574) dated 19.03.2024 was afforded to these candidates to submit the necessary documents within 21 days, which again did not evoke any response.

Now, therefore, and in view of the above, the withheld recommendations of the candidates, as figuring in **Annexure-A**, in the Final Selection List notified vide No. JKSSB/55/2022-05(E-7048574) dated 20.07.2023 for 80 posts of Class-IV (now MTS), earmarked under Horizontal Reservation for the Sub-category of Deaf & Hard of Hearing among the Persons with Disabilities (PwDs) and advertised vide Notification No. 01 of 2020 dated 26.06.2020, are hereby **cancelled**.
