- **3. H.S.C. or equivalent certificate** in support of declaration of age issued by the concerned Board/Council.

- 5. Diploma in Engineering (Mechanical) pass certificate wherever applicable.
- **6.** Degree in Mechanical Engineering pass certificate issued by the recognized University / Institution recognized by the Government.
- Mark lists of all semesters in support of Degree/Diploma in Mechanical Engineering passed including fail marks, if any, issued by the concerned Council/University;
