- i) Age (SSC),
- ii) Proof of age relaxation,
- iii) Educational Qualifications,
- iv) Study Certificates (from IV to X class),
- v) Integrated Community Certificate in case of reserved candidates.
- vi) Non-creamy layer certificate in case of B.Cs from Revenue Authorities (As per G.O. Ms. No.3, Backward Classes Welfare (C-2) Department, Dt: 04/04/2006 and G.O.Ms.No.26, BC Welfare (C) Dept., Dt:09-12-2013 who claim reservation under BC Community.
- vii) Migration certificates for candidates who migrated from Telangana to Andhra Pradesh.
- viii) Sanitary Inspector Training Certificate issued by the Director of Public Health

3. In case of failure to produce any of the certificates, they will not be treated as eligible with reference to the particulars furnished by him/her in the Online Application Form / Certificates. The candidature of such candidates shall not be considered in the process of selection. The Commission has the right to disqualify any candidate, if he/she is not found eligible for any reason.

The provisionally qualified Candidates are directed to download the call letter/Memo, Check lists and Attestation forms from the Commission's website: <https://psc.ap.gov.in>. and submit all the certificates and forms in duplicate (2 sets). The individual Memo's will be sent to the candidates separately.
