2. <u>ESSENTIAL QUALIFICATIONS</u>, <u>ELIGIBILITY CRITERIA</u>, <u>EXPERIENCE</u>, <u>LOCATION</u>: The applicant should satisfy eligibility criteria regarding educational/professional qualifications</u>, length of experience, required Experience, Age Limit, etc. as given in Annexure-I.

Notes: i) All mandatory educational/professional qualifications should have been obtained from a recognized university/deemed university/autonomous institutes in corporate by an Act of Parliament or State Legislature in India or UGC Actor from Government approved/ recognized institutions.

8. Other Instructions:

- a) <u>Intimation for Screening/Interaction</u>: Information for Screening/Interaction shall be intimated through e-mail/RVNL website. - b) Candidates currently serving in Govt/Quasi Govt. offices/Public Sector Undertakings shall have to submit "No Objection Certificate" from their employer at the time of Screening/Interaction, failing which they shall not be allowed to appear in Screening/Interaction and their candidatures shall be treated as cancelled.
