## SUPPLEMENTARY RESULT NOTICE NO.: |S|\ SPECIAL EDUCATOR (PRIMARY) In MUNICIPAL CORPORATIONS OF DELHI, Post Code 32/21

- 1. The DSSSB vide its advertisement No. 01/2021 dated 04/03/2021 and subsequent corrigendum dated 10/03/2021 had advertised 1126 vacancies (EWS-54, UR-487, OBC-328, SC-164, ST-93 including PwD/OH-23 and PwD/VH-22) for the Post of Special Educator (Primary) under post code 32/21 in Municipal Corporations of Delhi, with closing date 14/04/2021.
- 2. The written examination (online mode in three shifts) Tier-I (Technical) for recruitment in respect of this post was conducted on 17/10/2021. The candidature of Ms. Tanisha Ansari (Roll No. 324032100178), one of the candidate in above post code 32/21, was rejected vide Rejection Notice No. 1400 dated 01.07.2022 as she failed to upload the OBC (Delhi) certificate issued prior to cut off date/closing date of application form i.e. 14.04.2021. Further, she could not be selected vide Result Notice No. 1401 dated 01.07.2022.
- 3. Ms. Tanisha Ansari (Roll No. 324032100178) filed O.A. No. 2112/2022 in Hon'ble CAT. Hon'ble CAT vide order dated 25.08.2023 allowed the OA and set aside the rejection of the applicant with following directions:-
  - "11. In view of the present OA, the impugned rejection and treating the applicant as Unreserved qua the applicant is liable to be set aside. We allow the present OA directing the respondents that the applicant shall be treated as OBC candidate and shall be issued appointment letter within two months from the date of receipt of a certified copy of this order. We further direct that once the offer of appointment has issued, the applicant shall be entitled to notional seniority only subject to the last selected candidate in her category. The actual salary shall be granted to the applicant from the date of actual joining.
  - 12. No order as to costs."
- 4. The above Order of Hon'ble CAT was challenged in Hon'ble High Court, Delhi by filing Writ Petition (C) No. 16098/2023 titled as "DSSSB Vs Tanisha Ansari & Anr. But the same was dismissed by Hon'ble High

Court of Delhi vide Order dated 11.01.2024. Further, Hon'ble Supreme Court vide order dated 12.08.2024 has also dismissed the SLP (C) No. 8315/2024.

- 5. Accordingly, in compliance with the Order dated 25.08.2023 of Hon'ble CAT in OA No. 2112/2022, Ms. Tanisha Ansari (Roll No. 324032100178) is hereby provisionally nominated, under OBC Category, for the post of Special Educators (Primary) under post code 32/21 in Municipal Corporation of Delhi, subject to fulfilling all others conditions of eligibility and also correctness of information furnished by the candidate in her online application form and e-dossier.
- 6. As per the Board's resolution dated 14/07/2022 and as per decision of the Board dated 20/01/2023, no scrutiny of documents in the dossier and of the other terms and conditions of recruitment notified by the Board in the advertisement of the said post code has been done by the Board. The eligibility as per Recruitment Rules and other terms and conditions as specified in the Advt. No. 01/2021 & its corrigendum/ addendum etc. (if any) and relaxation as per rules in respect of educational qualifications, experience, other certificates shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the Post Code 32/21 before issuance of offer of appointment of the post.
- 7. The provisional nomination of the above 01 candidate (OBC-01) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- 8. The provisional nomination of the above 01 candidate (OBC-01) shall further be subject to genuineness of the documents on the basis of which she has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of her identity with reference to her photograph, signature/handwriting, etc. on the application form, admission certificate, etc. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about her eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 9. The User Department i.e. Municipal Corporations of Delhi shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the

scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

- 10. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidate is fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 11. The User Department shall also get the SC/ST/OBC/EWS certificates verified from the issuing authority before her appointment. Further, in case of OBC Candidate, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No.36033/3/2004-Estt.(Res) dated 14/10/2008 OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017 OM No. 36039/1/2019-Estt. (Res) dated 31/01/2019.
- 12. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about her eligibility as laid down in the recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 13. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 14. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.

- 15. The recruitment process for the Post of Special Educators (Primary) under post code 32/21 in Municipal Corporation of Delhi has already been closed. Further, the Wait List panel of the candidates had already been expired on 30/06/2023.
- 16. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 17. The nomination of the candidate is subject to outcome of review petition filed in the matter, if any. Further, the User Department shall also ensure that subsequent appointment and any other action will be subject to outcome of review petition filed in the matter at any stage.
