3. The provisionally shortlisted candidates will have to mandatorily i) **upload their documents** and ii) **submit their preference of post(s)** if applicable by logging into the website www.apssb.nic.in using their credentials from **23.08.2024 (10.00 AM) to 29.08.2024 (03.00 PM)**. The following documents are to be uploaded:

- a. 02 (two) copies of recent passport size photograph.
- b. Matriculation certificate issued by the Board / University for proof of date of birth.
- c. Class X or equivalent marksheet and pass certificate.
- d. Class XII or equivalent marksheet and pass certificate (wherever applicable).
- e. APST Certificate (if applicable).
- f. Permanent Resident Certificate (if applicable).
- g. Intimation letter to HoD for those who are in regular Govt. Service.
- h. Discharge book and Pay and Pension Order (PPO) for Ex-Servicemen.
- i. Valid driving licence Light Motor Vehicle (LMV) and Heavy Motor Vehicle (HMV) as applicable.
- j. Admit Card.
- k. For Post Code- 71/20- Constable (Driver) Civil Police: Experience of driving Light Motor Vehicle for atleast 03 (three) years.
- l. For Post Code 70/20- Head Constable Driver: Experience of driving Heavy Motor Vehicle for atleast 03 (three) years (**Desirable**).

4. Failure to upload documents and submit post preferences shall result in rejection of candidature and non-allotment of post.

5. The provisionally shortlisted candidates should bring their original documents and photocopy of the documents mentioned at 3 (a) to 3 (l) on the day of Document Verification.

The provisionally shortlisted candidates for Post Codes 70/20-Head Constable (Driver) & 71/20-Constable (Driver) Civil Police **whose documents are found in order shall be required to clear Medical Fitness Examination (as per Advertisement No. 09/2020 dated 21.01.2020) in order to be selected for the posts.** The details regarding batch, venue, date and time for Medical Examination will be notified after the completion of Document Verification process.

7. The candidature of all the shortlisted candidates is PROVISIONAL and subject to their eligibility in all respects as prescribed in the Advertisement and Recruitment Rules.

8. Candidates must note that their candidature is purely provisional at this stage and their name figuring in the Provisional Select List will be subject to Document Verification, Medical Test (if applicable), Preferences indicated and other eligibility criteria as mentioned in Advertisement No. 09/2020 dated 21.01.2020, failing which their candidature may be summarily rejected at any stage.

9. Further, the Appointing Authority i.e., the indenting / user department verifies the character and antecedents of the candidates, authenticity of documents/ certificates and eligibility as per the Recruitment Rules before finally appointing the candidate(s). Therefore, the provisional short listing of a candidate does not confer upon him/ her any right of appointment unless the Appointing Authority is satisfied, after such inquiry as may be considered necessary, that the candidate is suitable in all respects for appointment to the post.
