Please note that final correction shall be applicable only after payment of an additional fee if required. In case of change in Category, or PwBD, if there is an impact on the fee amount then the Candidate will be charged an excess fee as applicable. Excess payment made will not be refunded, if any.

All the registered candidates for the said Examination are advised to visit the website (<https://exams.nta.ac.in/NTET/>) and verify their particulars. They are further advised to make correction/s in their particulars, in their respective Application Form, if required.

The candidates are allowed to make the corrections, latest by **26 October 2024 (up to 11:50 P.M.)**. Thereafter, no correction in particulars, whatsoever, will be entertained by NTA under any circumstances. The additional fee (wherever applicable) shall be paid by the candidate concerned either through **Credit/Debit Card/Net Banking/UPI**.

Since, it is a one-time facility extended to the candidates to avoid any hardship to them, the candidates are advised to do the correction very carefully, as no further opportunity for correction will be given to the candidates.
