- vii. Latest Punjab Residence certificate (all reserve categories) issued by competent authority
- viii. Experience certificate issued by competent authority (if applicable)
- ix. For ESM, certificates/documents mentioning the following:-
 - a) Date of Enrolment
 - b) Date of Release/Discharge
 - c) Reason of Release/ Discharge
- x. Certificate as proof of age relaxation claim (if applicable)
- xi. Certificate as proof of fee concession (if applicable)
- xii. Proof of being a government employee (if applicable)
