COMPLIANCE OF ORDER OF HON'BLE HIGH COURT, DELHI VIDE ORDER DATED 19/07/2024 OF WP (C) NO. 2814/2024 & OTHER SIMILAR MATTERS & ORDER OF Ld. CAT, DELHI DATED 08/08/2023 IN O.A. NO. 1525/2022, 1754/2022 & ORDER DATED 13.10.2023 IN OA No. 1551/2022

For Post Code 39/21, for post of TGT SOCIAL SCIENCE (MALE)
In DIRECTORATE OF EDUCATION, Govt. of NCT of Delhi

1. This is in continuation of **Result Notice No. 132 Dated 28.04.2022**.
2. The DSSSB vide its advertisement No. 02/2021 dated 12/05/2021 had advertised 469 vacancies (EWS-35, UR-295, OBC-116, SC-21 and ST-02 including 19 PwD (OH-09, VH-10) of TGT Social Science (Male), under Post Code – 39 / 21 in Dte of Education, Govt. of NCT of Delhi.
3. The written examination (online mode) Tier-I (Technical) for recruitment in respect of post code 39/21 was conducted on 06/09/2021.
4. Total 5 candidates of EWS category, whose candidature was rejected vide Rejection Notice no. 131 dated 28.4.2022 filed O.A. No. 1525/2022, 1754/2022, 1551/2022 in Hon'ble CAT, Delhi. Hon'ble CAT vide order dated 08.08.2023 & order dated 13.10.2023 allowed the OA and set aside the rejection of these applicants in EWS category.
5. The above Order of Hon'ble CAT was challenged in Hon'ble High Court, Delhi by filing Writ Petition (C) No. 2814/2024, 15889/2023, 15912/2023, 15953/2023, 16440/2023 and 16552/2023 titled as "GNCTD Vs Rishikesh Sharma and others in similar matters. But the same was dismissed by Hon'ble High Court of Delhi vide Order dated 19.07.2024.
6. Accordingly, in compliance of the order of Hon'ble High Court, Delhi vide order dated 19/07/2024 of WP (C) no. 2814/2024 & other similar matters and orders of Ld. CAT, Delhi dated 08/08/2023 in O.A. no. 1525/2022, 1754/2022 & order dated 13.10.2023 in OA no. 1551/2022, the following EWS category candidates are hereby provisionally nominated, for the post of TGT – Social Science (Male) under post code 39/21 in Directorate of Education, GNCTD, subject to fulfilling all others conditions of eligibility and also correctness of information furnished by the candidates in their online application form and e-dossiers.

7. **The Board has not undertaken any scrutiny of documents uploaded in the e-dossier at this stage as per Board's resolution/decision dated 14/07/2022.** The eligibility as per Recruitment Rules and other terms and conditions as specified in the Advt. No. 02/2021 & its corrigendum/ addendum etc. (if any) and relaxation as per rules in respect of educational qualifications, experience, other certificates shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the Post Code 39/21 before issuance of offer of appointment of the post.
8. The provisional nomination of the above 05 candidates (EWS-05) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
9. The provisional nomination of the above 05 candidates (EWS-05) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of her identity with reference to her photograph, signature/handwriting, etc. on the application form, admission certificate, etc by the User Department. **The candidature of the candidate is liable to be cancelled by the User Department, in case,**

candidate does not fulfill any of the eligibility conditions of the Recruitment Rules for the post or for any genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate. The Competent Authority of the User Department concerned shall issue the offer of appointment to the candidate after being satisfied about his/her eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

10. The User Department shall also check the eligibility of the reservation benefit claimed by the candidates, if any. Further, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate, if applicable. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. The User Department is requested to ascertain the scrutiny/correctness of the same at its own level before issuing the offer of appointment to the provisionally selected candidate. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at its own level.
11. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidates in the light of Notification No. 36012/22/93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/ guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC(Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Deptt, GNCTD after thorough verification of caste certificate.
12. The User Department shall also get the SC/ST/OBC/EWS certificates verified from the issuing authority before their appointment. Further, in case of OBC Candidate, it may also be verified that the candidates does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/ 2004-Estt. (Res) dated 09/03/2004 and OM No.36033/3/2004-Estt.(Res) dated 14/10/2008 OM No. 36033/1/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017 OM No. 36039/1/2019-Estt. (Res) dated 31/01/2019.
13. Further, in case of EWS candidates, it may also be verified that the validity of EWS certificate should be as per DOPT OM No. 36039/1/2019-ESTT(Res) dated 31.01.2019 and other instructions/ guidelines issued from time to time in this regard by the competent authorities.
14. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about their eligibility as laid down in the recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
15. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
16. The result process for the above post code stands closed in all respect. Waiting panel was valid for a period of one year from the date of declaration of result i.e. upto 24.08.2023 as per Main Result Notice No. 132 dated 24.08.2022. The current supplementary result is declared for compliance of order dated 08.08.2023 & order dated 13.10.2023 of Hon'ble CAT, Delhi in O.A. No. 1525/2022, 1754/2022, 1551/2022.
17. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
18. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.

19. This is intimated to the User Department and the candidates mentioned above that the Result Notice shall be subject to final outcome of Review Petition/appeal filed in the matter, if any. Further, the User Department shall also ensure that subsequent appointment and any other action will be subject to outcome of review petition/appeal filed in the matter at any stage, if any.
20. This issues with the prior approval of Chairman, DSSSB.
