Among other selectees, the recommendation in respect of below mentioned candidate was also kept withheld on account of deficiency indicated as below:

The Board decided to release the withheld recommendation of the candidate Mr. Chowdari Akhtar, selected as Depot Assistant, Department of (Food, Civil Supplies & Consumer Affairs), District Cadre, Kashmir in respect of Advertisement No. 03 of 2020 dated 01.12.2020.

The above recommendation shall be subject to the outcome of writ petition(s)/O.A(s), if any, pending disposal before any competent Court of law/jurisdiction related to the selection. This shall also be subject to the outcome of any inquiry, involving candidate(s), figuring in this selection List.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates ascertaining the genuineness/validity etc. or otherwise of the same and recognition status of the institution, shall be responsibility of the Indenting Department/Appointing Authority.

It is further requested that in case any certificate/document, during the course of verification, turns out to be fake/fictitious, appropriate criminal proceedings against such candidate(s) may kindly be initiated and the Board may kindly be kept informed.

Moreover, in terms of Government Order No. 1003-JK (GAD) of 2021 dated 27.09.2021, the candidates whose recommendation is released by the Selection Agency shall submit their Personal Verification Rolls (PVR) before the appointing authority within a period of **21 days** from its release, failing which the candidate(s) shall forego his right to appointment forthwith.
